REQUESTED ACTION

1. Authorize the Department of Transportation to enter into a contract with Pike Industries, Inc. (Vendor 177300) of Belmont, NH, on the basis of a low bid of \$2,648,373.38 for pavement preservation of three Tier 2 roadway segments in the eastern portion of the state totaling approximately 8 miles, from the date of Governor and Council approval through September 27, 2019, unless extended by the Department in accordance with the Standard Specifications. 100% Federal Funds.

Funding is available in State Fiscal Year 2019 and is contingent upon the availability and continued appropriation of funds in Fiscal Year 2020 as follows, with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:



EXPLANATION

This project is part of the State's Ten Year Transportation Improvement Plan, Paving-Tier 2-Resurfacing. This project consists of pavement preservation involving bonded wearing course treatment (BWC) along three Tier 2 roadway segments in the eastern portion of the state totaling 7.5 miles, including:

- Atkinson-Hampstead, NH 111, 3/" full width BWC, crack filling, and intersection inlays, 4.9 miles;
- Greenland, NH 33, 34" full width BWC, crack filling, and intersection inlays, 0.9 miles; and

Greenland-Portsmouth, NH 33, ¾" full width BWC, crack filling, and intersection and RR inlays, 1.7 miles.

Incidental work includes inlays on several bridges, asphaltic bridge joint replacement and crack control plug joint repair on several bridges, and upgrading curb ramps to ADA standards.

The purpose of this project is to extend the life of the existing pavement infrastructure and eliminate the need for more costly improvements in the near-term.

The proposed contingency amount is 5% of the contract amount. This project has limited survey; and therefore, items have been quantified based on field observations, aerial photos, and as-built plans and field adjustments may be required due to varying field conditions.

Although the bid costs exceeded the Department's estimate by 3.75%, the low bid of 3 bids received is felt to be reasonable for the work involved. Readvertising this project would result, in our opinion, in higher prices and prevent the completion of the work in a timely manner. The Department considers it to be in the best interest of the State to accept this bid to accomplish these needed repairs.

The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

This project funding is 80% Federal funds (Paving-Tier 2-Resurfacting) utilizing Turnpike Toll Credits as the State's 20% match, effectively using 100% Federal Funds.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

Your approval of this resolution is respectfully requested.


