REQUESTED ACTION

Authorize the Department of Natural and Cultural Resources, Division of Parks and Recreation (Department) to make a **RETROACTIVE** payment to Rowell's Services (VC #167877), Tilton, NH, for \$14,481 for replacement of a septic tank at Bear Brook State Park per invoice dated May 15, 2019. **100% Agency Income**

EXPLANATION

In May of 2019, the septic system at Bear Brook State Park failed and Rowell's Services was contacted to evaluate the situation. The bathrooms at the campground were deemed inoperable due to the failed septic tank at the Park. The campground was open, and the sites utilizing this bathhouse were fully reserved. The South Region Manager and the Bear Brook State Park manager deemed the lack of bathroom facilities to be an emergency and engaged Rowell's Services to replace the Septic Tank immediately. There was no time in which to obtain proposals or proceed through the normal Purchasing procedures. Rowell's was able to replace the septic tank and have the bathrooms operational very quickly. Due to this emergency, the Department is now seeking retroactive approval to make payment to this vendor.

Replace 2000 Gallon Septic Tank:

Objective & Scope of Work:

- The Service Experts will cut the asphalt around the existing 2000-gallon septic tank in front of the restrooms. The Service Experts will excavate around the tank and remove the old non-HD tank and dispose of all concrete. A new 2000-gallon HD tank will be installed in its place and all connections to the existing pipes will be made. The Service Experts will install 3 riser covers with steel access covers over each cover of tank. The area will be back-filled with some of the existing material and some new gravel will be brought in to bring to grade. Any disturbed asphalt will be replaced.
- Protect the property & clean the work area upon completion.
- · Pull all necessary permits that may be required.
