**REQUESTED ACTION**

Authorize the Department of Transportation to enter into a contract with Pike Industries, Inc. of Belmont, NH (Vendor 177300) on the basis of a single bid of \$5,921,800.00 for resurfacing of approximately 102 miles in District II in Grafton, Merrimack and Sullivan Counties, from the date of Governor and Council approval through September 30, 2016 unless extended by the Department in accordance with the Standard Specifications. 42.2% Betterment Funds, 57.8% Agency Income.

**EXPLANATION**

This project is included in the State's Ten Year Transportation Improvement Plan and part of the annual Maintenance District resurfacing program with additional funding for paving through the SB 367 Road Toll Increase. This project involves pavement resurfacing of approximately 102 miles of state highways in the District Two region. The resurfacing will preserve and extend the life of the highway riding surface and protect the subsurface base course materials. All of the proposed work will remain within the right-of-way.



Although there was only one bid received and the bid costs exceeded the Department's estimate, this bid is felt to be reasonable for the work involved. The bid was consistent with their other resurfacing bids. For the most part, the differences were in the mobilization and cold planing items. Readvertising this project would result, in our opinion, in higher prices and prevent the completion of the work in a timely manner. The Department considers it to be in the best interest of the State to accept this bid to accomplish these needed repairs.

The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

## SUPPLEMENTAL PROJECT INFORMATION SHEET

**DESCRIPTION:** This project involves resurfacing under three programs. The Betterment-Maintenance program (16162E) includes 15 sections totaling 46 miles of roadways including sections along East Side Dr (Wentworth), Wentworth Village Rd (Wentworth), Etna Rd (Lebanon), NH 118 (Canaan-Dorchester), NH 114 (Springfield-Grantham), NH 120 (Claremont-Cornish), Yeaton Rd (Plymouth), Fairgrounds Rd (Plymouth), NH 25 (Piermont), River Rd (Piermont), Townhouse Rd (Cornish), Four Corners Rd (Springfield), Second NH Tpk (Unity-Claremont), County Farm Rd (Unity), and NH 4A (Enfield-Grafton). The SB-367-Maintenance program (40192) includes 10 sections totaling 39 miles of roadways including sections along NH 116 (Haverhill-Benton), NH 135 (Haverhill), US 302 (Haverhill), NH 120 (Plainfield-Lebanon), East Unity Rd (Newport), NH 12A (Cornish-Plainfield), NH 104 (Danbury), NH 25A (Orford), NH 118 (Dorchester-Rumney), and Main St (Plainfield). The SB-367-Roughness program (40192) includes 8 sections totaling 17 miles of roadways including sections along Canaan St (Canaan), Etna Rd (Hanover), Corbin Rd (Newport), Trues Brook Rd (Lebanon), Shaker Hill Rd (Enfield), Main St (Enfield), Groton/North Groton Rd (Hebron-Groton), and Halls Brook Rd (Groton).

**FEDERAL FUNDING:** 0% (42.2% Betterment and 57.8% Agency Income)

**CONTINGENCY:** None.

**PROJECT INITIATED:** State's 10-Year Transportation Improvement Program under Pavement Strategies: Tier 2 Maintenance, Tier 3-4 Maintenance, Tier 3-4 Roughness.

**PROJECT EXPLANATION:** These roadways are located throughout District 2 and serve various functions. These pavements are in fair to poor condition. The intent of this project is to maintain and improve the riding surface and to extend the life of the existing roadways. All of the proposed work will remain within the right-of-way.

**TRAFFIC IMPLICATIONS:** Minimal traffic implications are anticipated. Alternating one-way traffic will be allowed only on roads with pavement widths less than forty-eight feet. Normal traffic patterns will be re-established prior to the beginning of non-work hours. No work on 16231, Etna Rd (Hanover); 16212, NH 116 (Haverhill-Benton); 16214, US 302 (Haverhill); 16219, NH 25A (Orford); 16202, NH 114 (Springfield-Grantham); 16207, River Rd (Piermont); 16209, Four Corners Rd (Springfield); and 16220, NH 4A (Enfield-Grafton) shall take place from July 8 to July 11 due to the Prouty Bike Race. No work will be permitted from May 27 to May 31, July 1 to July 5 and from September 2 to September 6, 2016.


