# REQUESTED ACTION

- 1. That approval be and hereby is given to the Attorney General to grant a salary increase to Susan G. Morrell, as an Assistant Attorney General (Position #9U499, Appropriation #02-20-20-20-2010-2610-013-500132) from a salary level of \$99,845.25 to a salary level of \$106,000 retroactive to July 1, 2019 upon Governor and Executive Council approval.
- 2. Upon approval of Requested Action #1 above, it is further requested that approval be granted and hereby is given to the Attorney General to reappoint Susan G. Morrell, as an Assistant Attorney General (Position #9U499, Appropriation #02-20-20-200510-2610-013-500132) at a salary level of \$106,000, effective upon Governor and Executive Council approval or January 17, 2020, whichever is later, for a term ending October 27, 2024.

#### **EXPLANATION**

In accordance with the 2001 N.H. Laws Chapter 158, Section 101, and 2018 N.H. Laws Chapter 162, Section 14, this request seeks your approval to grant a salary increase for Assistant Attorney General Susan G. Morrell. **Requested Action #1** of this item is **retroactive** because funds in the Fiscal Year 2020-2021 biennium budget were not available to submit this request prior to July 1, 2019.

RSA  $94:1-\overline{a}(I)(c)(3)$  provides that designation of positions, salary levels, and salary increases for attorneys at the Department of Justice shall be determined by the Attorney General, subject to approval of the Governor and Council, within appropriations made to the Department of Justice.

Requested Action #2 seeks authorization to reappoint Susan G. Morrell as an Assistant Attorney General, effective upon Governor and Executive Council approval, or January 17, 2020, whichever is later, for a term ending October 27, 2024.

Ms. Morrell lives in Portmouth. She received her law degree from Franklin Pierce Law Center (now UNH School of Law) in 1984. Ms. Morrell was an attorney for the City of Keene from 1984 through 1987. She was an attorney for the Strafford County Attorney's Office from 1987 through 1990. Ms. Morrell joined the Department of Justice as an Assistant Attorney General from 1990 through 1995. She left the office and became an attorney for Shaheen & Gordon P.A. from 1995 through 1996. Ms. Morrell returned as an attorney to the Strafford County Attorney's Office from 1996 through 1999. She resumed her duties at the Department of Justice in 1999 as an Assistant Attorney General in the Criminal Bureau. Ms. Morrell was designated a Senior Assistant Attorney General in 2009. Her salary will increase by \$6,155, from \$99,845.25 to \$106,000. I plan to continue her assignment in the Criminal Bureau.

I am very pleased to offer Ms. Morrell for reappointment as an Assistant Attorney General at the above-referenced salary for your approval. I respectfully urge your favorable consideration. Thank you.
