REQUESTED ACTION

1. Authorize the Department of Transportation to enter into a contract with Mitchell Sand & Gravel, LLC (Vendor 225114) of Shelburne, MA on the basis of a low bid of \$772,561.00 for NH 119 intersection safety improvements in Fitzwilliam, from the date of Governor and Council approval through August 23, 2019 unless extended by the Department in accordance with the Standard Specifications. 100% Federal Funds.

Funding is available in State Fiscal Year 2019 and is contingent upon the availability and continued appropriation of funds in Fiscal Year 2020 as follows, with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:

EXPLANATION

This project is part of the State's Ten Year Transportation Improvement Plan under the Highway Safety Improvement Program (HSIP). This project involves the construction of traffic calming measures along NH Route 12 at the approaches to the NH Route 119 intersection in Fitzwilliam. Work begins on NH Route 12 approximately 1800' south of the NH Route 119 intersection, and continues north to a pavement joint approximately 1400' north of the NH Route 119 intersection. Approach work on NH Route 119 begins approximately 200' east of the NH Route 12 intersection and continues west to approximately 150' west of the NH Route 119 intersection. Work along NH Route 12 includes the construction of raised concrete median islands on the NH Route 119 approaches, step box widening in the median areas, minor drainage work, and reallocating pavement to provide a two way left turn lane (TWLTL). The southern approach will construct an 11'-4' typical transitioning to include a variable width painted median which then transitions to a 12' TWLTL. The northern approach will construct an 11'-4' typical transitioning to include a variable width painted median, which then converts to a designated left turn lane at the NH Route 119 intersection. For both approaches, in the area where the painted gore is 4' or greater in width, rumble strips will be installed leading into the raised concrete median islands. The rumble strips shall be installed inside the painted gore area. The proposed culvert work will include culvert extensions, catch basin replacement, and headwall replacement. Pavement work involves a 1-1/2" overlay with variable shim throughout the project limits. Work on NH Route 119 includes widening the eastern approach to accommodate right turning trucks and adjusting the grade on the western approach to provide a platform to improve sight distance at the intersection.

This project originated as a Ten Year Plan project, but ultimately was removed from the program and resulted in a Road Safety Audit (RSA) being conducted by NHDOT in 2009 which determined the project to be eligible for HSIP funds. The purpose of this project is to encourage drivers to reduce speeds through the intersection by changing the nature of the roadway.

The proposed contingency amount is 5% of the contract amount. The surveyed information for this project is from 2011. Field adjustments may be required for paving, leveling course and shoulder work due to varying field conditions.

The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

This project funding is 90% federal funds with 10% state match. Turnpike toll credit is being utilized for match requirements, effectively using 100% federal funds.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

SUPPLEMENTAL PROJECT INFORMATION SHEET

DESCRIPTION: This project involves the construction of traffic calming measures along NH Route 12 at the approaches to the NH Route 119 intersection in Fitzwilliam. Work begins on NH Route 12 approximately 1800' south of the NH Route 119 intersection, and continues north to a pavement joint approximately 1400' north of the NH Route 119 intersection. Approach work on NH Route 119 begins approximately 200' east of the NH Route 12 intersection and continues west to approximately 150' west of the NH Route 119 intersection.

Work along NH Route 12 includes the construction of raised concrete median islands on the NH Route 119 approaches, step box widening in the median areas, minor drainage work, and reallocating pavement to provide a two way left turn lane (TWLTL). The southern approach will construct an 11'-4' typical transitioning to include a variable width painted median which then transitions to a 12' TWLTL. The northern approach will construct an 11'-4' typical transitioning to include a variable width painted median, which then converts to a designated left turn lane at the NH Route 119 intersection. 
CONTINGENCY: The proposed contingency amount is 5% of the contract amount. The surveyed information for this project is from 2011. Field adjustments may be required for paving, leveling course and shoulder work due to varying field conditions.

PROJECT INITIATED: This project was initiated through the Road Safety Audit program.

PROJECT EXPLANATION: This project originated as a Ten Year Plan project, but ultimately was removed from the program and resulted in a Road Safety Audit (RSA) being conducted by NHDOT in 2009 which determined the project to be eligible for HSIP funds. The purpose of this project is to encourage drivers to reduce speeds through the intersection by changing the nature of the roadway.

TRAFFIC IMPLICATION: Proposed traffic control for the project includes temporary lane closures. One-lane, alternating two-way traffic will be utilized as needed during step box widening, raised concrete median island construction, and resurfacing efforts. All closures will be completed during daytime work hours; no night work is anticipated for this project. This project is anticipated to be completed within one construction season.
