

BOARD OF AUCTIONEERS MINUTES
Legislative Office Building Room 303, Concord, NH
May 3, 2013, 9:00 a.m.

1. The Board of Auctioneers convened at 9:00 a.m. with, Chairperson Russell R. Abbott, Vice-Chairman Roy W. Tilsley, Member Frank L. Eaton and Member Richard C. Berman present. Secretary Gregory J. Walsh was absent.
2. The Board on motion of Roy W. Tilsley, seconded by, Richard C. Berman accepted the minutes of the April 1, 2013 meeting.
