Your Excellency and Members of the Council:

**REQUESTED ACTION**

That approval be and hereby is given to the Attorney General to give a salary increase to Mitchell L. Weinberg, M.D., Deputy Chief Medical Examiner (Position #9U427; Appropriation #02-20-202010-1033-015-500137), from \$240,000 to \$250,000, effective upon Governor and Executive Council approval or April 22, 2022, whichever is later.

**EXPLANATION**

Dr. Weinberg received his degree as a Doctor of Medicine from the University of South Florida in May 2008. He completed his residency in Anatomic Pathology at The Ohio State University in June 2011 and was the Chief Resident from July 2010 to June 2011. Dr. Weinberg was a Forensic Pathology Fellow at the Maryland Office of the Chief Medical Examiner from 2011 to 2012. He was the Assistant Chief Medical Examiner for the Alberta Office of the Chief Medical Examiner, Edmonton, Alberta, Canada, from 2012 until he joined the Department as Deputy Chief Medical Examiner in 2020. Dr. Weinberg is Anatomic Pathology Board Certified and Forensic Pathology Board Certified through the American Board of Pathology. He is also Forensic and Anatomic Pathology Certified by the National Board of Physicians and Surgeons.

On July 19, 2017, the Governor and Executive Council approved the Joint Committee on Employee Classification's recommendation to establish a salary range of \$200,000 to \$260,000 for the position of Deputy Chief Medical Examiner. Dr. Weinberg has not had a salary increase since his appointment effective April 24, 2020. Pursuant to RSA 94:3-b, Dr. Weinberg's salary will increase by \$10,000 from \$240,000 to \$250,000. He will continue to serve as Deputy Chief Medical Examiner.
