#### **REQUESTED ACTION**

Authorize the Department of Environmental Services to budget and expend prior year carry forward funds under the provisions of RSA 125-C:6, in the amount of \$29,650 for purposes of covering staff salaries for work performed associated with the settlement agreement with American Electric Power effective upon Governor and Council approval through June 30, 2017. Funding to be budgeted as follows, 100% other funds.

#### **EXPLANATION**

In 2007, the State of New Hampshire along with seven other states settled litigation with American Electric Power (AEP) for alleged violations of the federal Clean Air Act. Under the settlement agreement, AEP is required to pay the state \$240,000 per year for five years. DES received the first of these payments in FY 2009. In accordance with the settlement agreement, DES must propose specific projects to use said funds on an annual basis to AEP for concurrence that the project proposals are consistent with the agreement. In 2009, DES proposed the use of these funds to support a Climate and Energy Analyst position within the Air Resources Division. AEP concurred that the use of these funds was consistent with the Consent Decree. In order to account for the climate and energy work completed in accordance with AEP Consent Decree, DES is requesting the use of prior year carryforward funds in the AEP Account for FY17 to cover the transfer of expenditures for work performed by the Climate and Energy Program Manager in FY17.

DES is requesting authorization to budget and expend \$29,650 in prior year carry forward funds, and to budget those funds as follows:

Class 050 – *Personnel Services* – *Temporary* - The additional funds in class 50 will not be used to support any new positions. These funds are available in continued support of climate and energy work related to the AEP settlement agreement. These funds will be used to supplant funding of the following position, which is currently budgeted:

Classes 040, 041, and 060 – *Indirect Costs, Additional Fringe and Benefits* – No changes are necessary in these classes as there are sufficient funds available to cover any expenses.
