## REQUESTED ACTION

1. Authorize the Department of Transportation to enter into a contract with Pike Industries, Inc. (Vendor 177300) of Belmont, NH on the basis of a low bid of \$3,358,918.00 for 2.1 miles of pavement resurfacing on NH 101 from Manchester to Auburn and on the I-93 to I-293 ramps in Hooksett; and rehabilitation of a bridge on the I-93 NB to I-293 SB ramp, from the date of Governor and Council approval through June 29, 2018 unless extended by the Department in accordance with the Standard Specifications. 87% Federal Funds and 13% Turnpike Funds.

2. Further authorize that a contingency in the amount of \$100,767.54 be approved for payment of latent conditions, which may appear during the construction of the project. The contingency requested is 3% of the contract amount.

### **EXPLANATION**

This project is part of the State's Ten Year Transportation Improvement Plan, under the Tier I Preservation Program and involves 2.1 miles of pavement resurfacing on NH 101 from Manchester to Auburn and on the I-93 NB to I-293 SB and I-293 NB to I-93 SB ramps in Hooksett; and rehabilitation of a Bridge on the I-93 NB to I-293 SB ramp. The resurfacing treatment generally involves a 2-inch travel way inlay. Additional improvements include guardrail reset/replacement, NH-101 Exit #1 pedestrian sidewalk ramp, signal and crosswalk improvements, minor rock scaling and tree clearing, recessed polyurea pavement marking improvements along NH 101 between Manchester and Epping (approximately 15 miles per barrel), and limited street light relocation and/or removal on the NH-101 Exit #1 ramps. Rehabilitation of the I-93 NB to I-293 SB Bridge in Hooksett

(Bridge # 068/099) is programmed through the Turnpike System. NH-101 Exit #1 pedestrian signal improvements will be completed by the Bureau of Traffic. Eversource Energy shall supplement street light relocation and/or removal under a Utility Supplement Agreement.

The purpose of this project is to preserve and extend the life of the existing pavement and to prevent the Hooksett Bridge # 068/099 from being added to the "near Red List". Bureau of Materials & Research (December 2016) assessed the proposed resurfacing treatment areas to be in fair condition. The NH 101 section was last resurfaced in 2005 and the I-93 NB to I-293 SB and I-293 NB to I-93 SB ramps were last resurfaced in 2000 and 2001 respectively. Hooksett Bridge # 068/099 was built in 1976 and has had prior preservation improvements completed in 1992. Inspection reports show that the concrete deck, superstructure, and expansion joints are deteriorating.

Although the bid costs exceeded the Department's estimate, the low bid is felt to be reasonable for the work involved as there were 2 bids submitted for this project and the low bid is within 0.1% of the Department's estimate. Readvertising this project would result, in our opinion, in higher prices and prevent the completion of the work in a timely manner. The Department considers it to be in the best interest of the State to accept this bid to accomplish these needed repairs.

The contingency is proposed to be 3% of the contract amount. The project was not surveyed and therefore, items have been quantified based on field observations, as-built plans, and aerial photos. Field adjustments may be required (for guardrail work, bridge work, paving, etc.) due to varying field conditions.

The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

This project includes 13% Turnpike Renewal and Replacement Funds. The balance is funded 80% federal funds with 20% state match. Turnpike toll credit is being utilized for match requirements for 87% of the total, effectively using 100% federal funds.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

## SUPPLEMENTAL PROJECT INFORMATION SHEET

**DESCRIPTION:** This project is part of the 2017 Tier I Preservation Program and involves 2.1 miles of pavement resurfacing on NH 101 from Manchester to Auburn and on the I-93 NB to I-293 SB and I-293 NB to I-93 SB ramps in Hooksett; and rehabilitation of a Bridge on the I-93 NB to I-293 SB ramp. Additional improvements include guardrail reset/replacement, NH-101 Exit #1 pedestrian sidewalk ramp, signal and crosswalk improvements, minor rock scaling and tree clearing, recessed polyurea pavement marking improvements along NH 101 between Manchester and Epping (approximately 15 miles per barrel), and limited street light relocation and/or removal on the NH-101 Exit #1 ramps. Rehabilitation of the I-93 NB to I-293 SB Bridge in Hooksett (Bridge # 068/099) will be programmed through the Turnpike System. NH-101 Exit #1 pedestrian signal improvements will be completed by the Bureau of Traffic. Eversource Energy shall supplement street light relocation and/or removal under a Utility Supplement Agreement.

FEDERAL FUNDING: Federal 80% (Pave-T1-Pres)/ State 20% (TTC); 100% Turnpikes (TRR)

**CONTINGENCY:** The contingency is proposed to be 3% of the contract amount. The project was not surveyed and therefore, items have been quantified based on field observations, as-built plans, and aerial photos. Field adjustments may be required (for guardrail work, bridge work, paving, etc.) due to varying field conditions.

**PROJECT INITIATED:** This project was initiated through the Tier I Pavement Preservation Program.

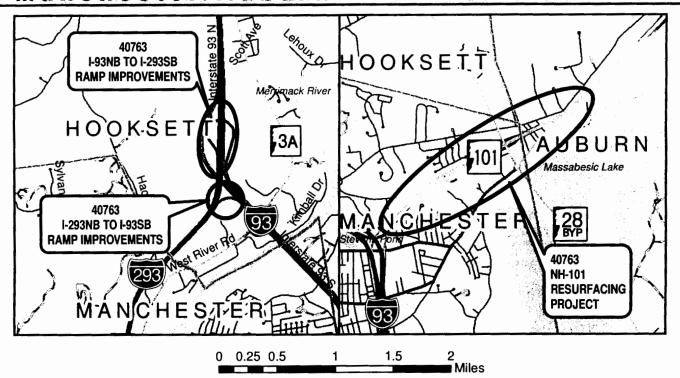

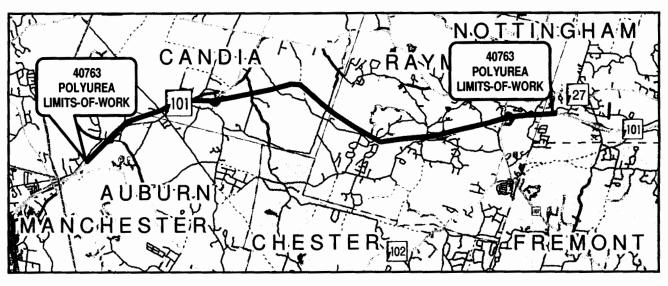
TRAFFIC IMPLICATION: Two lanes of traffic per barrel will be maintained on NH-101 for all daytime work. Night work (8pm-6am) will be required during paving and striping operations on NH-101 and may utilize a single lane closure per barrel. NH-101 daytime work will use a lane shift/shoulder closure, and existing traffic patterns will be restored during non-work hours. NH-101 Exit 1 ramp work will require short-term, nighttime only (8pm-6am) ramp closures, during which traffic will be detoured via NH-101 Exit 2 and I-93 Exit 8. The I-93 and I-293 ramp work, inclusive of the work at Hooksett Bridge No. 068/099, will require a detour via NH 3A between I-93 Exit 10 and I-293 Exit 7.

**INTERMEDIATE COMPLETION DATE:** October 27, 2017 for all work with the exception of the I-93 NB to I-293 SB ramp.

FINAL COMPLETION DATE: June 29, 2018.

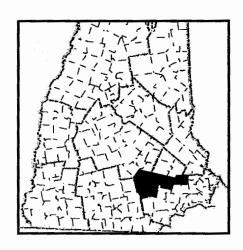
