REQUESTED ACTION

That approval be and hereby is given to the Attorney General to designate Christopher G. Aslin, (Position #9U038, Appropriation #02-20-20-200510-2613-013-500132) as an Assistant Attorney General at a salary level of \$79,672. Mr. Aslin is occupying a position for a five-year term, effective upon Governor and Executive Council approval or July 29, 2022, whichever is later, through July 18, 2023.

EXPLANATION

Mr. Aslin, a Concord resident, is a member of the New Hampshire Bar. He received a Bachelor of Arts in Biology from Dartmouth College in 1997, Master of Arts in Psychology from Vanderbilt University in 2002, Master of Environmental Management from Yale School of Forestry and Environmental Studies in 2007, and Juris Doctor, *summa cum laude*, from Vermont Law School in 2007. He practiced with Bernstein, Shur, Sawyer & Nelson, P.A. from 2007 to 2014. He joined the Department in 2014, has been assigned to the Environmental Protection Bureau since that date, and was designated a Senior Assistant Attorney General in 2018. He served as Chair of the New Hampshire Bar Association Environmental and Natural Resources Law Section from 2014 to 2015. A copy of his resume is attached


