## **REQUESTED ACTION**

Authorize the New Hampshire Department of Corrections to increase their fleet by two (2) vehicles pursuant to Administrative Rule 611.08 (g).

## **EXPLANATION**

The New Hampshire Department of Corrections is requesting authorization to increase our fleet of vehicles by an additional two (2) vehicles. These two (2) vehicles are needed to accommodate the additional two (2) canine teams funded in HB-517. Canine vehicles require specific equipment that limits the use of the vehicle to that single purpose, and our current fleet cannot absorb the loss of two vehicles.
