REQUESTED ACTION

Pursuant to RSA 4:8, authorize the New Hampshire Fish and Game Department to accept a donation of forty (40), Moultrie Outdoor Game Cameras from the New Hampshire Operation Game Thief valued at approximately \$4000.00 to be donated to the Law Enforcement Division to be utilized for Fish and Game Investigations and Law Enforcement Patrol purposes.

EXPLANATION

New Hampshire Operation Game Thief is an important tool in combating wildlife violations. It is a crime line callers can utilize to anonymously report Fish and Game violations. The Operation Game Thief Program is a non-profit organization funded through sportsmen and women's financial donations. Over the past ten years this program has successfully raised enough funds to not only support the operation of this program but also to make donations to law enforcement with needed equipment to aid in the investigation or detection of wildlife crimes. This donation of outdoor game cameras will aid New Hampshire's Conservation Officers with a myriad of law enforcement challenges to include illegal dumping or littering, trespass complaints or the illegal taking of game.
