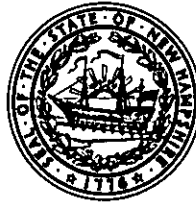

Your Excellency and Members of the Council:

REQUESTED ACTION

That approval be and hereby is given to the Attorney General to appoint Emily C. Goering (Position #9U584, Appropriation #02-20-20-201010-2623-013-500132) as an Assistant Attorney General, at a salary level of \$65,422.50, effective upon Governor and Executive Council approval or November 23, 2018, whichever is the latter. Ms. Goering will be occupying a position with a term that ends on August 15, 2023.

EXPLANATION

Ms. Goering is a resident of Canterbury and a member of the New Hampshire Bar. She received her law degree from the University of New Hampshire School of Law in 2016 and her undergraduate degree from the University of Southern Maine in 2011. She joined the Department of Justice in November 2017 as an attorney in the Transportation and Construction Bureau. Prior to joining the Department, Ms. Goering worked at the law firm of Hudkins Law, PLLC in Concord. In view of Ms. Goering's performance over the past year, I am requesting her current salary be increased by \$3,000 from \$62,422.50 to \$65,422.50. This pay raise will become effective on November 23, 2018. A copy of her resume is attached. I plan to continue her assignment in the Transportation and Construction Bureau.

2001 Laws of NH Chapter 258, amended RSA 94:1-a(I)(c)(3) to provide that designation of positions, salary levels, and salary increases for attorneys at the Department of Justice shall be determined by the Attorney General, subject to approval of the Governor and Council, within appropriations made to the Department of Justice.


