Requested Action

Pursuant to Chapter 276:198, Laws of 2015, authorize the Department of Safety, Division of State Police to transfer among accounts within State Police Traffic Bureau, as outlined below, in the amount of \$86,000.00 for anticipated shortages in current expense and employee training for the remainder of the Fiscal Year 2017. Effective upon Fiscal Committee and Governor and Council approvals through June 30, 2017. Funding source: 52.17% General Funds, 25% Highway Funds and 22.83% Turnpike Funds.

Explanation

The Department of Safety, Division of State Police, Traffic Bureau requires a transfer of appropriations to support current expense and employee training expenditures through the end of the Fiscal Year. A transfer of \$80,000.00 into Class 020 appropriations is needed to complete outfitting State Police Troopers with active shooter kits including sights and tourniquet cases. A transfer of \$6,000.00 into Class 066 appropriations is needed to provide Peer Support Training sessions for all State Police sworn personnel in late June. Appropriations in Class 070 and 039 are available as actual costs have been lower than budgeted estimates.

The following information is provided in accordance with the Budget Officer's instructional memorandum dated April 17, 1985 to support the above requested actions:

Does transfer involve continuing programs or one-time projects? The transfer involves continuing programs.

Is this transfer required to maintain existing program level or will it increase the program level? This transfer is required to maintain existing program levels.

Identify the source of funds on all accounts listed on this transfer. The source of funds for all accounts listed on this transfer is 25% Highway Funds, 22.83% Turnpike Funds, and 52.17% General Funds.

Will there be any effect on revenue if this transfer is approved or disapproved? There will be no effect on revenue.

Are funds expected to lapse if this transfer is not approved? Yes, the funds will lapse if the transfer is not approved.

Are personnel services involved? No.

276: 198 Department of Safety; Transfer Among Accounts. Notwithstanding any provision of law to the contrary, except RSA 9:17-c and RSA 99:4, for the biennium ending June 30, 2017, the commissioner of the department of safety is hereby authorized to transfer funds between and among all class lines and accounting units within the department as the commissioner deems necessary and appropriate to address present or projected budget deficits, or to respond to changes in federal law, regulations, or programs, and otherwise as necessary for the efficient management of the department; provided that any transfer over \$75,000 shall require prior approval of the fiscal committee of the general court and the governor and council.
