### **REQUESTED ACTION**

1. Authorize the Department of Transportation to enter into a contract with Pike Industries, Inc. (Vendor 177300) of Belmont, NH on the basis of a low bid of \$4,465,169.10 for roadway rehabilitation project that will improve the pavement condition of approximately 7.3 miles of roadway by resurfacing US Route 1, from the intersection of Lamson Lane in Hampton, proceeding north through North Hampton and Rye, to just south of Peverly Hill Road in Portsmouth, from the date of Governor and Council approval through June 21, 2019 unless extended by the Department in accordance with the Standard Specifications. 100% Federal Funds.

Funding is available in State Fiscal Year 2018 and 2019 as follows, with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:

2. Further authorize that a contingency in the amount of \$223,258.46 be approved for payment of latent conditions, which may appear during the construction of the project. The contingency requested is 5% of the contract amount.

#### **EXPLANATION**

This project is part of the State's Ten Year Transportation Improvement Plan under the Tier 2 Pavement Preservation Program. This roadway rehabilitation project will improve the pavement condition of approximately 7.3 miles of roadway by resurfacing US Route 1, from the intersection of Lamson Lane in Hampton, proceeding north through North Hampton and Rye, to just south of Peverly Hill Road in Portsmouth. Proposed pavement treatments include:

• 3" cold plane with 3" HBP inlay (Lamson Lane to North Road, 2.5 miles), 1.5" (top wearing course) of high strength HBP within the Private Road at Lafayette Crossing and NH 111 signalized intersections

- 3/4" paver shim overlay (North Road to North Road, 0.2 miles, future North Hampton 24457 project)
- 3" cold plane with 3" HBP inlay (North Road to Ocean Road, 2.8 miles), 1.5" (top wearing course) of high strength HBP within the Breakfast Hill Road/Washington Road signalized intersection
- 1" cold plane with 1" high strength HBP (Ocean Road to Peverly Hill Road, 1.8 miles, future Portsmouth 29640 project)

The goal of the Pave-T2-Rehab program is to rehabilitate Tier 2 roadways to avoid more costly reconstruction in the future. US Route 1 was originally constructed in 1920 as a concrete roadway, and has received various pavement treatments since, most recently including overlays in 2002 (Lamson Lane to North Hampton/Rye Town line) and 2009 (North Hampton/Rye Town line to just south of Peverly Hill Road), as well as a paver drag shim in 2016 (full length).

The contingency amount is proposed at 5% of the contract amount. All plan work was derived from field observations, as-built plans, and aerial photos only. Departure from estimated quantities due to varying field conditions, specifically for pavement markings and hot mix asphalt paving, can potentially increase costs.

The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

This project funding is 80% federal funds with 20% state match. Turnpike toll credit is being utilized for match requirements, effectively using 100% federal funds.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

#### SUPPLEMENTAL PROJECT INFORMATION SHEET

**DESCRIPTION:** This roadway rehabilitation project will improve the pavement condition of approximately 7.3 miles of roadway by resurfacing US Route 1, from the intersection of Lamson Lane in Hampton, proceeding north through North Hampton and Rye, to just south of Peverly Hill Road in Portsmouth. Proposed pavement treatments include:

- 3" cold plane with 3" HBP inlay (Lamson Lane to North Road, 2.5 miles), 1.5" (top wearing course) of high strength HBP within the Private Road at Lafayette Crossing and NH 111 signalized intersections
- 3/4" paver shim overlay (North Road to North Road, 0.2 miles, future North Hampton 24457 project)
- 3" cold plane with 3" HBP inlay (North Road to Ocean Road, 2.8 miles), 1.5" (top wearing course) of high strength HBP within the Breakfast Hill Road/Washington Road signalized intersection
- 1" cold plane with 1" high strength HBP (Ocean Road to Peverly Hill Road, 1.8 miles, future Portsmouth 29640 project)

Ancillary improvements include pavement markings, replacement of guardrail, replacement of deteriorated culverts and other minor drainage work, and curb and curb ramp upgrades. Additionally, minor bridge work on Bridge No. 163/184 in Hampton is included, as well as traffic signal improvements at the US Route 1 intersections with Ocean Road, Springbrook Circle and Wilson Road in Portsmouth.

**FEDERAL FUNDING:** 80% (Pave-T2-Rehab) with anticipated utilization of Turnpike Toll Credits as the State's 20% match

**CONTINGENCY:** The contingency amount is proposed at 5% of the contract amount. All plan work was derived from field observations, as-built plans, and aerial photos only. Departure from estimated quantities due to varying field conditions, specifically for pavement markings and hot mix asphalt paving, can potentially increase costs.


**PROJECT INITIATED:** Tier 2 rehabilitation program under State Ten-Year Transportation Improvement Program


**PROJECT EXPLANATION:** The goal of the Pave-T2-Rehab program is to rehabilitate Tier 2 roadways to avoid more costly reconstruction in the future. **TRAFFIC IMPLICATIONS:** Traffic impacts are anticipated as daily lane closures during nonpeak hours for guardrail, drainage, and traffic signal work. The milling and paving work, as well as the pavement markings, will be done at night to minimize the impacts to traffic. Time restrictions for lane closures will be specified in the contract.




