EXPLANATION

Mr. Maki is a resident of Peterborough, and a member of the New Hampshire Bar. He received his law degree from Suffolk University Law School, Boston, Massachusetts in 2010, and his Bachelor of Arts in Criminal Justice and Political Science from Franklin Pierce College in 2006. Mr. Maki interned at the Department of Justice in the summer of 2008. He went on to become the prosecuting attorney for the Town of Wilton Police Department from March 2011 through May 2015, and has been a regional prosecutor for the Cheshire County Attorney's Office from May 2015 to the present. In view of Mr. Maki's experience, I am requesting he be appointed as an Attorney at a salary of \$68,000. He will be the Traffic Safety Resource Prosecutor and assigned to the Criminal Justice Bureau. A copy of his resume is attached.
