## **EXPLANATION**

The Charitable Trust Escrow Account is made up of civil penalties collected pursuant to RSA 7:28-f, II (d). The Department requests authorization to use existing prior year carry forward funds from the Charitable Trust Escrow Account to budget and continue funding two existing part-time positions. The Charitable Trust Unit has 7.5 staff members to monitor all charitable trusts and charitable organizations in the State of New Hampshire. Two long-term staff members, the deputy director and the investigative paralegal, retired but returned on a temporary part time basis to help with the workload and train their replacements.

In the event these funds should become unavailable, general funds will not be requested in support of this request.
