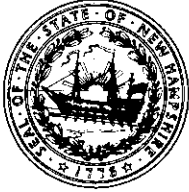



Section V
