#### REQUESTED ACTION

In accordance with Administrative Rule Adm 611.08 (g), the Department of Natural and Cultural Resources, Division of Parks and Recreation, Bureau of Trails respectfully requests permission to increase their fleet size by one truck effective upon Governor and Executive Council approval.

#### **EXPLANATION**

The Division of Parks and Recreation recently added the position of Deputy Chief within the Bureau of Trails to support the increased demand and use of the statewide trail system and for increased administrative oversight. The primary purpose of this position is administering agency objectives and overall operations of the Trails Bureau within the Division of Parks and Recreation in conjunction with the Trails Bureau Chief. The Deputy Chief position requires use of vehicle transportation in order to carry out the duties and responsibilities as assigned, and the position serves to oversee overall operations in the absence of the Chief. Also, in order to meet public demand, scheduling often requires the Chief and Deputy Chief to be in multiple places at the same time. Additionally, this position requires a vehicle equipped with the ability to carry a heavy load of equipment and the capacity to tow fully loaded trailers. For this reason, we are requesting approval for an additional fleet vehicle.

The Bureau Trails is requesting to add a ¼ ton capacity pickup truck. This pickup truck is a necessity for this additional position to fulfill the job requirements. Funding for the truck is available in account 03-035-035-351510-34140000-030-500300. Source of funds is 100% Other Funds.
