## **EXPLANATION**

This request is being made to accept grant funds available to implement the CSTE Social Determinants of Health Supplement for the NH PRAMS survey. The overall function of NH PRAMS is to reduce infant morbidity and mortality and to promote maternal health by influencing maternal and child health programs, policies, and maternal behaviors during pregnancy and early infancy. Collecting population-based data of high scientific quality on topics relating to pregnancy and early infancy may lead to improvement in the health of mothers and infants in the Granite State by disseminating and using the data to:

- Develop and implement new programs or to modify existing programs.
- Monitor progress toward established health objectives.
- Influence public health policy by working with policy makers to incorporate findings into the decision-making process.
- Provide input into legislative proposals.
- · Make recommendations for new policies.
- Disseminate research findings to the health community so they may incorporate the latest information into their standards of practice.

Implementing the Social Determinants of Health questions into the NH PRAMS survey provides opportunities to specifically address two of New Hampshire's Title V MCH priorities, which are, 1) to improve access to needed healthcare services for all MCH populations, and 2) to increase the focus of Title V on the Social Determinants of Health and the resolution of barriers impacting the health of the MCH populations. NH PRAMS will work with stakeholders to refine the analysis plan and determine best methods and venues for dissemination of the data and the framing of the promotional messages. Methods of disseminating findings include a topic summary report, data briefs, and presentations at stakeholder meetings.

The funds are to be budgeted as follows:

Class 010 These funds will be used to support the salary of the existing PRAMS program manager position while working on this initiative.

Class 020 These funds will be used to purchase office supplies used by staff members to carry out daily activities of the program. A participation incentive is included with the questionnaire mailed to each family. A reward will be provided to the respondent after a completed questionnaire is received by the program.

Class 060 These funds will be used to support benefits for the PRAMS program manager.
