EXPLANATION

The New Hampshire Insurance Department (NHID) requests authorization to transfer funds among various budgeted accounts in order to fund the permanent classified vacant positions in FY 2017. The transfer of appropriation is being requested in order to put the Department in a position to be able, with appropriate authorizations, to fill, in 2017, the 10 currently vacant positions.

Class 046	Decrease Consultants by \$100,000 to move the necessary funds to the correct class line as this transfer will align expenditures to the proper class line per accounting policy.
Class 060	Increase Benefits by \$100,000 to cover benefit expenses and enable the department to fill the current vacant permanent classified positions.
Class 102	Decrease Contract for Program Services by \$200,000 to move the necessary funds to the correct class line as this transfer will align expenditures to the proper class line per accounting policy.

The following transfer of appropriation authority is being requested for Fiscal Year 2017:

1. The \$ 300,000 transfer of appropriation is required in order to fund the department's vacant positions for the remainder of FY2017.
