REQUESTED ACTION

Pursuant to RSA 94:6, the New Hampshire Department of Employment Security respectfully requests approval for Karen A. Levchuk, General Counsel, (Position # 9U080) to be placed at a compensation level higher than the minimum established in RSA 94:1-a. This request is to place Attorney Levchuk's annual salary in Group GG, Step 6, \$101,536.24 (range \$76,462.36 - \$101,536.24), appropriation #010-027-8040-012, (100% Federal Funds), effective upon Governor and Council approval or October 12, 2018, whichever is later.

EXPLANATION

After careful consideration, I would like to appoint Karen A. Levchuk to the position of General Counsel beginning October 12, 2018. This is a previously established unclassified position within the Department that needs to be filled in accordance with 282-A:136. The position has been vacant since July 31, 2018 as a result of the retirement of the incumbent. This position is vital to the operation and management of the Legal Department, but also in an advisory capacity to me as the Commissioner of the New Hampshire Department of Employment Security.

Attorney Levchuk began practicing law nearly thirty (30) years ago. She spent nine (9) years with the New Hampshire Department of Justice (seven (7) as Assistant Attorney General and the last two (2) as Chief of the Transportation and Construction Bureau). She spent approximately five (5) years as Assistant Attorney General at the Colorado Attorney General's Office overseeing complex litigation before returning to New Hampshire at the end of 2003.

In the fifteen (15) years since returning to New Hampshire, Attorney Levchuk has held positions in the public sector as well as the private sector allowing her to develop expertise in all aspects of employment law. Attorney Levchuk has practiced before the Department representing clients and spent three (3) years working for the Department as legal counsel. This experience uniquely positions her to be able to hit the ground running and successfully oversee the Department's legal section.

Attorney Levchuk's substantial experience and excellent performance in both the public as well as the private sector, make her an exceptional candidate for this position and the Department will benefit from her legal expertise and ideas for furthering its mission.
