REQUESTED ACTION

1. Authorize the Department of Transportation to enter into a contract with J Hutchins Inc. (Vendor 285855) of Richmond, VT on the basis of a low bid of \$1,807,706.50 for 7.4 miles of pavement resurfacing in Colebrook and Stewartstown, from the date of Governor and Council approval through August 28, 2020, unless extended by the Department in accordance with the Standard Specifications. 100% Federal Funds.

Funding is available in Fiscal Year 2020 and Fiscal Year 2021, with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:

2. Further authorize that a contingency in the amount of \$90,385.33 be approved for payment of latent conditions, which may appear during the construction of the project. The contingency requested is 5% of the contract amount.

EXPLANATION

This project is part of the State's Ten Year Transportation Improvement Plan under the Paving-Tier 2-Resurfacing Program and involves 7.4 miles of pavement resurfacing on NH 26 in Colebrook and US Route 3 in Colebrook and Stewartstown.

- 18117 – Colebrook, NH 26, 3" cold planing, 2" full width high strength inlay, 0.6 miles
- 19131 – Colebrook/Stewartstown, US 3, 3/4" full width paver shim (3.9 mi), 2" full width high strength inlay (0.3 mi), 4.2 miles
- 19136 – Colebrook, NH 26, 2" full width high strength inlay, 0.2 miles
- 19137 – Colebrook, US 3, 3/4" full width paver shim, 1.7 miles
- 21101 – Stewartstown, US 3, 2" full width high strength inlay (0.3 mi) 3/4" full width paver shim (0.4 mi), 0.7 miles.

The purpose of this project is to extend the life of the existing pavement infrastructure and minimize the need for costlier improvements in the near future.

The proposed contingency amount is 5% of the contract amount. This project was quantified based on field observations, aerial photos, and as-built plans. Field adjustments may be required due to varying field conditions. In addition, the sections will continue to deteriorate through the 2019-2020 winter and asphalt prices are currently in escalation.


The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

This project funding is 80% Federal (Paving-Tier 2-Resurface) utilizing Turnpike Toll Credits as the State's 20% match, effectively using 100% Federal Funds.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

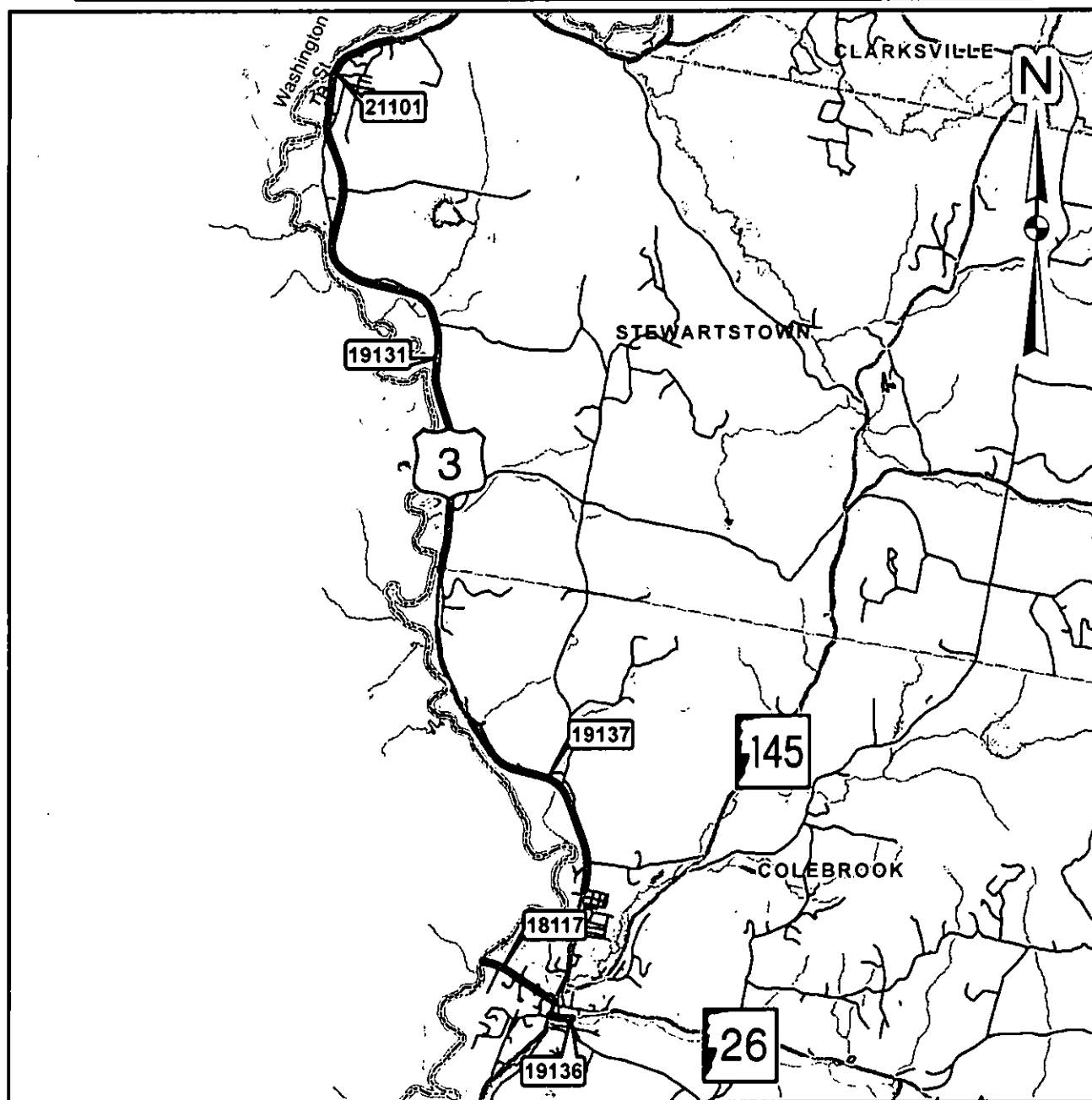

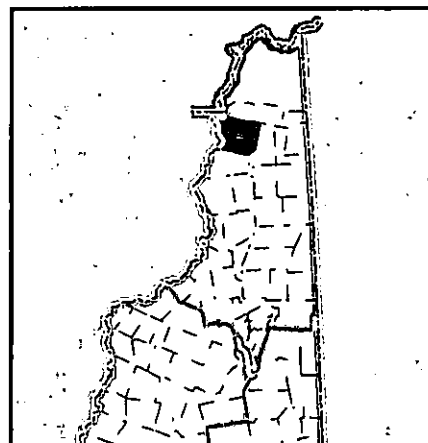
