#### **EXPLANATION**

The Department of Environmental Services Dam Bureau owns and manages 150 parcels of land located throughout the state and totaling approximately 9,500 acres in area. In addition, the Department is responsible for designing and implementing all repair and reconstruction projects on all 278 State-owned dams, which are either owned in fee or easement. This course will give Mr. Bell, who is the Department's Chief Surveyor, a fuller understanding of survey evidence and the laws for boundary location for efficient, accurate boundary and easement determination as it relates our properties. This course will give Mr. Bell an overview of liability & limitation on liability as it relates to the Courts and Land surveyor. The Course will also speak to boundary establishment doctrines such as adverse possession and prescriptive rights.

This course is an on-line course, and Mr. Bell will be attending the course outside of normal work hours, and not on State time. Both Mr. Bell and the Department feel strongly that continuing education relating to his employment is necessary and proper to ensure property boundaries are determined accurately, and the correct legal standards are being applied to boundary situations as they arise. Land surveying is a complicated and litigious endeavor and the fact that the major portion of Mr. Bell's work concerns boundary determinations around important littoral and riparian rights and significant State-owned infrastructure requires a high level of professional competency that should be maintained and reinforced.

Mr. Bell is required to sign a contract, which obligates him to work for the State for six months after satisfactory completion of the courses. He must also complete and achieve a passing grade. If he does not comply with the terms of the contract, he will be liable for returning the amount paid. The course he will be taking is directly related to his responsibilities as the Department's Chief Surveyor.

This tuition assistance has been a very successful program of the Department and has resulted in many benefits to the State. The cost is minimal when compared to the cost of salary and benefits. The course being taken directly relates to the individual and their job accountabilities, and we have found that this program is an excellent way to train individuals so they can keep up with the latest developments in their work. We have encouraged Mr. Bell to take these courses as part of our professional development plan.

4.	4. Upon the satisfactory completion of the courses named in paragraph 1, the Recipient shall continue in the employ of the State in his/her current position (or in such other position, at equal or greater compensation, to which he/she may be assigned) for a period of six (6) months.					
5.	The Recipient shall work in any area of the State to which he/she may be assigned, provided that such assignment will not constitute a severe hardship to said Recipient.

Should the Recipient breach any of the conditions set forth in paragraphs 4 and 5, the Recipient shall pay to the State a sum equal to all monies previously paid by the State for the Recipient pursuant to the Agreement, provided, however, that the Recipient shall receive a credit for each month in which he/she is employed by the State subsequent to the date upon which the named course(s) are satisfactorily completed, the value of said credit to be calculated on a pro rata basis.					
7.	The Recipient shall not raise any setoff or counterclaim against the State in any action brought by the State to collect any amount due under this agreement.					

8. Should any amount be found to be due the State in any action brought against the Recipient pursuant to this Agreement, the State shall, in addition to said amount, be entitled to an award of costs and a reasonable amount in "attorney" fees.
