EXPLANATION

This request will enable the New Hampshire Employment Program (NHEP) to access shared learning and network benefits with other states and counties. Members track and share aggregate programmatic outcomes and data with the use of the Bridge, a revised front end assessment tool which captures data from clients in a holistic method. This corresponds to the social determinants of health and direct department resources available. NHEP will be tracking performance measurements to improve our work participation rate requirement.

- 1. How long has this organization been in existence and how long has this agency been a member of this organization?
 - EMPATH (formerly Crittenton Women's Union established in 2006. There is no other organization providing case management technical assistance to our agency. This will be the first year in which DHHS has held a membership to this organization.
- 2. Is there any other organization that provides the same or similar benefits which your agency belongs to?
 - There are no other agencies providing this service.
- 3. How many other states belong to this organization and is your agency the sole New Hampshire state agency that is a member?
 - Currently there are 118 organizations in the EMPATH Learnig Network. Bureau of Employment

Supports (BES) is the sole Temporary Assistance to Needy Families (TANF) agency from New Hampshire involved with EMPATH.

Dues are based on experience, agency status and population served.

 - Includes all Level One benefits, plus:

 - o Access to EMPATH tools and tool updates including the Bridge to Self-Sufficiency® and Goal Action Plan and member-adapted tools.
 - o Invitation to participate in regular subgroup discussions with EMPATH and other Exchange member organizations.

 - Discounted training and technical assistance.

 - Access to purchase the Mobility Mentoring® Practitioner's Guide for an additional \$1,500 fee.
