REQUESTED ACTION

1. Authorize the Department of Transportation to enter into a contract with Pike Industries, Inc. (Vendor 177300) of Belmont, NH on the basis of a low bid of \$2,577,297.27 for resurfacing of various Tier 2 roadways in the Northern region, from the date of Governor and Council approval through August 28, 2020, unless extended by the Department in accordance with the Standard Specifications. 100% Federal Funds.

Funding is contingent upon the availability and continued appropriation of funds in Fiscal Year 2020 and Fiscal Year 2021 with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:

EXPLANATION

This project is part of the State's Ten Year Transportation Improvement Plan under the 2019 Federal Resurfacing Program (Paving-Tier 2-Resurface). The approximately 20 mile project consists of pavement preservation of five Tier 2 roadway segments in the northern portion of the state, including:

- 18121 Bartlett, US 202, 3/4" Paver Shim, 2.2 miles
- 18330 Conway, NH 16, 3/4" Paver Shim, 2.8 miles
- 19101 Carroll-Hart's Location, US 302, 3/4" Paver Shim, 4.8 miles
- 19132 Jackson-Pinkham's Grant, NH 16, 3/4" Paver Shim, 7.8 miles
- 20107A Bartlett, US 302, 3/4" Paver Shim, 2.6 miles.

This project is part of the Federal Resurfacing Program. The project will improve the roadway ride quality and therefore improve safety. The sections will be resurfaced via paver shim overlay. All impacted towns and utilities will be notified of the work. No guardrail or curb ramp ADA upgrades are required.

The proposed contingency amount is 5% of the contract amount. The project was not surveyed and therefore, items have been quantified based on field observations, as-built plans, and aerial photos. Field adjustments may be required due to varying conditions and asphalt prices are currently in escalation.

Although the bid costs exceeded the Department's estimate by 9.90%, the only bid received is felt to be reasonable for the work involved. Competition for paving contracts in District I continue to be a challenge. The bid price received is a direct reflection of the limited competition and is exacerbated by ongoing work force issues. Readvertising this project would result, in our opinion, in higher prices and prevent the completion of the work in a timely manner. The Department considers it to be in the best interest of the State to accept this bid to accomplish these needed repairs.

The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

This project funding is 80% (Paving-Tier 2-Resurface) utilizing Turnpike Toll Credits as the State's 20% match, effectively using 100% Federal Funds.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

Your approval of this resolution is respectfully requested.


