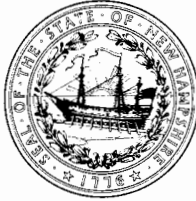

Your Excellency and Members of the Council:

**REQUESTED ACTION**

Authorize the Department of Justice to conduct a one day training for leaders in New Hampshire law enforcement. This training, entitled "Leadership – Liability – Lessons Learned: Domestic Violence, Sexual Assault, and Stalking", will be held at the Police Standards and Training Academy, Concord, New Hampshire at a cost not to exceed \$3,858 upon Governor and Executive Council approval through June 30, 2017. 100% Federal Funds.

Funds are available in Account #02-20-20-201510-2906-067-500559 training of providers entitled "Sexual Assault Regional Training".

**EXPLANATION**

The Department of Justice requests approval to conduct a one day training for law enforcement leaders. The goal of this training is to enhance efforts to promote best practices in the prevention, response, and investigation of domestic violence, sexual assault, and stalking crimes.

The training costs, totaling \$3,858 are detailed in the attached conference budget. This total includes supply costs, and speaker's expenses. In the event that federal funds become no longer available General Funds will not be requested to support this program.
