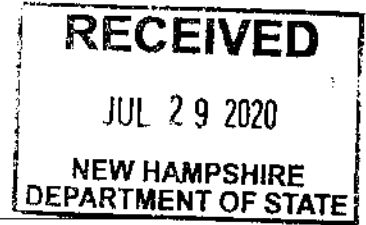



Section V
