REQUESTED ACTION

Authorize the Division of Public Works Design and Construction to enter into a contract amendment with D. L. King & Associates, Inc., (VC#168979) Nashua, NH, for the Supreme Court Roof, Concord, NH (Contract No. 7002448), which was approved by Governor and Council on June 20, 2018, Late Item #A, by increasing the base contract amount by \$18,539.40 from \$956,450 to \$974,989.40. This amendment will be effective upon Governor and Council approval through May 31, 2019 unless extended in accordance with the contract terms. **87.50% General Funds, .41% Transfer Funds and 12.09% Other Funds.**

EXPLANATION

This amendment is intended to resolve the ice damming issues at the State Supreme Court Building based on the most recent study recommendations.

Additional work includes insulation per the drawings in attics within the State Supreme Court building, including insulation repair for some existing ductwork, and the removal and disposal of existing asbestos imitation slate roof surface. Further work includes installation of new ventilated deck system, installation of new imitation slate roof surface, repair of cupola, and re-gilding of cupola dome.

On January 10, 2019, an alteration order was processed to move \$6,450 from the contingency approved on the June 20, 2018, Late item #A, into the contract, increasing the contract from \$950,000 to \$956,450.

The Department of Administrative Services has certified that the necessary funds are available. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Services, Division of Public Works Design and Construction.

- 3). Further authorize the amount of \$5,000 be approved for payment to the Department of Administrative Services, Division of Public Works Design and Construction (VC# 177875), for engineering services provided, bringing the total to \$961,475. **100% Capital - General Funds.**


EXPLANATION

Per Chapter 228:1, II, D, 4, Laws of 2017 for the Supreme Court Building – New Roof, Insulation, and Dome Repair, and Chapter 228:1, II, A, 2 Laws of 2017 for the Statewide Energy Efficiency Improvements Projects. This project will install insulation in attics within the State Supreme Court building, including insulation repair for some existing ductwork. Included is the removal and disposal of existing asbestos imitation slate roof surface. Work also includes installation of new ventilated deck system, new imitation slate roof surface, repair to the cupola, and re-gilding of the cupola dome.

The contractor has been pre-qualified by the Department of Transportation. The contract has been approved by the Attorney General as to form and execution, and the Department of Administrative Services has certified that the necessary funds are available. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Services, Division of Public Works Design and Construction.

DESCRIPTION: This project includes:

1. Insulation per the drawings in attics within the State Supreme Court building, including insulation repair for some existing ductwork.
2. Removal and disposal of existing asbestos imitation slate roof surface.
3. Installation of new ventilated deck system.
4. Installation of new imitation slate roof surface.
5. Repair of cupola
6. Re-gilding of cupola dome.

EXPLANATION: This project is intended to resolve the ice damming issues at the State Supreme Court Building based on the most recent study recommendations. Those recommendations include use of a ventilated deck system and spray foam insulation to create warm attics. To install the ventilated decking, the existing out of warranty, greatly degraded asbestos imitation slate roofing must be removed and replaced. The result is that the roofs, cupola, dome and icing issues will finally be resolved at the State Supreme Court Building.

**OVER ESTIMATE
EXPLANATION:**

This project has special considerations for: Security, Time Constraints, Limited access to the work. All of these factors have increased the price of the work.

Security: Requirements for security clearances to work on Supreme Court premises take additional time and limit the labor pool.

Time constraints: Schedule is shortened because of Court schedule. Schedule is also limited because spray

foam work must occur off hours for safety (fumes) reasons.

Work Access: Attics are tight and space is restricted making work difficult. Access to attics is also limited making access difficult for materials and labor.

In addition, we only had two bidders and the bids were inconsistent and high. We believe that this is because the construction market is extremely busy currently and because this is a more complicated and difficult job (due to schedule and limited access, construction complexity) it is less desirable. The pricing is therefore inflated to make the project worth their while.

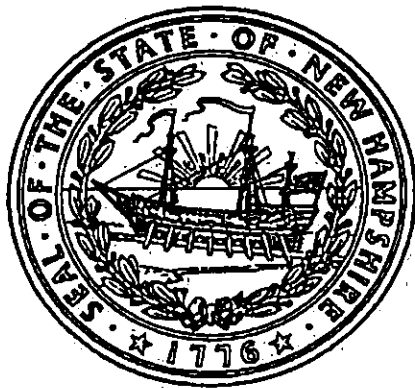
