To whom it may concern,

The Cyberize It, LLC platform uses Ideology for KBA and Credential Analysis of each unknown principal joining the session. The principal will be required to answer a minimum of 4 out of 5 questions within 2 minutes to achieve a passing score of 80%. The principal can take this quiz two times, then will be required to wait 24 hours before attempting it again. After the principal passes the KBA's then they will be required to upload an image of a valid government ID prior to joining the notary session. (See all accepted ID's here: https://notary.cyberizeit.com/id-validation-list/). You may notice Cyberize It, LLC does not require the input of a Social Security Number for KBA validation. Ideology does not use credit history for this validation, they use location data. The questions will be about places the Principal has lived or other public records based around location.

For the Audio/Visual system we use Zoom. As this is an API with Zoom, and the meeting url/password is not sent to the Principal or Notary until the Principal (and all signers) have successfully passed both KBA and ID credentialling, there is minimal risk of others joining the session. The meeting is secure, and the Notary can end the session at any time should any issues arise. At that point, the Notary can initiate contact with the signer to setup a new session to complete the notarization – if the reason the Notary canceled was not due to a concern of Fraud or Intimidation by another person for the principal to sign. Escalation procedures will be in place to protect the Notary and the Principal in all suspected cases.

For the document encryption and e-signature certification we are using Adobe, with the standard requirement of x.509 digital certificate for each signing party's signature. The Notary can also use their own digital certificate purchased from Identrust (and other vendors too). Notaries (and Principals) can also use multiple features for their Signature should they not use a Digital Certificate, to include the upload of an image of a "wet" signature. An audit trail of this transaction will also be made available to both the Notary and the Principal upon successful completion of this notarization.

Notaries can upload a .jpg or image of an electronic stamp that they already have or upload an image of their physical stamp. Cyberize It, LLC also will create said stamps for those that need them, as we have registered as a stamp manufacture to provide this service for free to the notaries on the platform.

The Notary will have immediate access to the video for 90 days, where they can download to retain on their own storage platform. And after such time the videos will be retained in long term cloud-based storage for at least 10 years. The Notary can request the video be sent to them at any time during this retention period.

The Notary will have full access to their e-journal and can download their journal to retain for their records at any time. Cyberize It, LLC will also retain a copy of this journal within our cloud system for the full 10-year term.

Cyberize It, LLC has retained insurance in the amount of \$1 Million dollars as a business enterprise.
