#### REQUESTED ACTION

Authorize the Governor's Office for Emergency Relief and Recovery (GOFERR) to amend a sole source agreement with New Hampshire Housing Finance Authority (NHHFA), 32 Constitution Drive, Bedford, NH. 03110 (VC# 174411) as part of the Housing Stability Services portion of the State's Emergency Rental Assistance program, which is funded under the Consolidated Appropriations Act, Section 501(a) Emergency Rental Assistance (ERA1), decreasing the price limitation by \$507,730, from \$1,773,000 to \$1,265,270, with no change to the completion date, effective upon Governor and Council approval through September, 30, 2022. This is an allowable use of ERA 1 Housing Stability Services funds under Section 501(c)(3). This item was originally approved by the Governor and Executive Council on September 15, 2021 (Item #49). 100% Federal Funds.

#### **EXPLANATION**

This is an amendment to an existing agreement with the New Hampshire Housing Finance Authority (NHHFA) to provide Housing Stability Services as part of the State's ERA program (the New Hampshire Emergency Rental Assistance Program, "NHERAP"). The amendment reduces the funds available for the purposes of Housing Stability Services so that they can be reallocated by NHHFA for the purpose of rental assistance. As a result, this change is in concert with other amendments to agreements with NHHFA relative to NHERAP. This amendment reflects a change in where funds are needed within the program and the State's ability to utilize them for an authorized purpose within timelines established by the federal government.

Therefore, we are requesting this amended that reduces the authorized funds by \$507,730 from \$1,773,000 to \$1,265,270. As a result of this request and in conjunction with others before the Governor & Executive Council, NHHFA will be given the authority to reallocate the \$507,730 currently authorized for Housing Stability Services to the broader eligible NHERAP uses of rental and utility assistance.

In accordance with the previously authorized agreement, NHHFA has already received the \$1,773,000 initially allocated, and no new funds would be provided to NHHFA as a result of this amendment.

The underlying agreement that is being amended enables NHHFA to leverage ERA1 resources to facilitate a key feature of NHERAP, Housing Stability Services. NHHFA has engaged in agreements with the five regional Community Action Partners (CAPs) to provide those services, including:

- Application assistance that helps households access ERA programs (assistance may be provided to both tenants and landlords);
- Housing counseling, including financial management, budgeting, tenants' rights, and finding another rental, if necessary;
- Case management related to housing stability, including referrals to and help with filling out applications for services offered by the CAP and Department of Health and Human Services;
- Fair housing counseling and referrals to NH Legal Assistance;
- Housing-related services for survivors of domestic abuse or human trafficking;
- Specialized services for individuals with disabilities or seniors that support their ability to access or maintain housing.

This item was **sole source** as NHHFA, as the sole statewide housing authority and the administrator of NHERAP, is uniquely positioned to administer this housing stability services program and manage the CAPs in their efforts to improve NHERAP access and leverage other available resources for the benefit of tenants as well as landlords whose tenants have fallen behind in payment of rent during the pandemic.

In the event that Federal Funds become no longer available, General Funds will not be requested to support this program.

#### ERA1 – Housing Stability Services

#### Grant Agreement Amendment #1

The State of New Hampshire Governor's Office for Emergency Relief and Recovery (GOFERR) and the New Hampshire Housing Finance Authority (NHHFA or Grantee) hereby mutually agree to amend the Grant Agreement previously entered into, signed by Governor and Council on September 15, 2021, to decrease the Price Limitation by \$507,730.00, in order to reallocate those funds for use in the ERA1 Rental Assistance program.

Wherefore the Grant Agreement is amended as follows:

- 1. Amend Section 1.8 of the Grant Agreement (Page 1) by decreasing the Price Limitation by \$507,730.00, from \$1,773,000.00 to \$1,265,270.00.
- 2. Amend Paragraph 1 of Exhibit B (Page 10) to read in its entirety as follows:

GOFERR will pay the Grantee, the sum of \$1,265,270.00 (the Grant Amount) for expenses incurred to support access to NHERAP assistance and leverage other resources to support housing stability.

3. All other provisions of the Grant Agreement executed by Grantee and signed by Governor and Council on September 15, 2021 shall remain in full force and effect.

As GOFERR has already paid the Grantee the sum of \$1,773,000.00 per Exhibit B, and as the \$507,730.00 is being reallocated from this program to the ERA 1 Rental Assistance program, Grantee hereby agrees to transfer the sum of \$507,730.00 from its ERA 1 Housing Stability Services account to its ERA 1 Rental Assistance account. Grantee agrees to provide proof to GOFERR, within fifteen business days of approval of this amendment by Governor and Council, that this transfer has occurred.

#### REQUESTED ACTION

Authorize the Governor's Office for Emergency Relief and Recovery (GOFERR) to enter into a sole source agreement with New Hampshire Housing Finance Authority (NHHFA), 32 Constitution Drive, Bedford, NH. 03110 (VC# 174411) in the amount of \$1,773,000 as part of the Housing Stability Services funding under the Consolidated Appropriations Act, Section 501(a) Emergency Rental Assistance (ERA1) for a part of the housing stability program for housing stability services due to the effects of the public health emergency, effective upon Governor and Council approval through September, 30, 2022. This is an allowable use of ERA 1 Housing Stability Services funds under Section 501(c)(3) to help keep households stably housed. Funding Source: 100% Federal Funds.

#### EXPLANATION

2. SCOPE OF ALLOWABLE USE OF FUNDS: In exchange for grant funds from the State under the Emergency Rental Assistance fund established by Title V, Subtitle A, Section 501(a) Division N of the Consolidated Appropriations Act, 2021, Pub. L. No. 116-260 (Dec. 27, 2020) (hereinafter referred to as "Section 501") provided by and subject to the terms of the award from the United States Department of Treasury, CFDA number 21.023, FAIN Nos. ERA0012 and ERA0435, to the State of New Hampshire, acting through the Agency identified in Paragraph 1.1 (hereinafter referred to as "GOFERR"), the Grantee identified in Paragraph 1.3 (hereinafter referred to as "the Grantee"), agrees and covenants that the funds will be used solely for an allowable purpose as defined in H.R. 133, Section 501(c) Division N, for which Grantee has not received payment or reimbursement from any other source, to provide Housing Stability Services under Section 501(c)(3) to help keep households stably housed by supporting the access to New Hampshire Emergency Rental Assistance Program and to leverage other available resources to keep eligible households stably housed.

The allowable purposes and use of funds are more specifically described in EXHIBIT A.

#### 3. EFFECTIVE DATE: COMPLETION OF GRANT.

This Agreement, is entered into and authorized by the State's Joint Legislative Fiscal Committee and the Governor and Executive Council and all obligations of the parties hereunder shall become effective on the date of execution of this Agreement by GOFERR ("the effective date").

Except as otherwise specifically provided herein, this Grant, including all activities and reports required by this Agreement, shall be completed in their entirety prior to September 30, 2022.

#### 4. GRANT AMOUNT: LIMITATION ON AMOUNT: VOUCHERS: PAYMENT.

The Grant Amount is identified in paragraph 1.8 and is more particularly described in EXHIBIT B, attached hereto. The manner of, and schedule of payment shall be as set forth in EXHIBIT B. In accordance with the provisions set forth in EXHIBIT B, and in consideration of the satisfactory performance of the Grant, as determined by the GOFERR, the GOFERR shall pay the Grantee the Grant Amount.

The payment by the GOFERR of the Grant amount shall be the only, and the complete payment to the Grantee for all expenses, of whatever nature, incurred by the Grantee and claimed as allowable expenses under this Agreement. To the extent that the Grant amount does not cover all of the Grantee's allowable expenses, nothing in this Agreement shall be construed to limit the Grantee's ability to pursue other state or federal funding that may be available. However, under this Agreement, the GOFERR shall have no liabilities to the Grantee other than the Grant Amount.

Notwithstanding anything in this Agreement to the contrary, and notwithstanding unexpected circumstances, in no event shall the total of all payments authorized, or actually made, hereunder exceed the Grant limitation set forth in Paragraph 1.8 of these general provisions.

5. COMPLIANCE BY GRANTEE WITH LAWS AND REGULATIONS. In connection with the

performance of the Grant, the Grantee shall comply with all statutes, laws, regulations, and orders of federal, State, county, or municipal authorities which shall impose any obligations or duty upon the Grantee, including the acquisition of any and all necessary permits.

#### 6. RECORDS AND ACCOUNTS.

Between the Effective Date and the date five (5) years after the Completion Date, the Grantee shall keep detailed accounts of all expenses incurred in connection with the Grant, including, but not limited to, costs of administration, transportation, insurance, telephone calls, and clerical materials and services. Such accounts shall be supported by receipts, invoices, bills and other similar documents.

Between the Effective Date and the date five (5) years after the Completion Date, at any time during the Grantee's normal business hours, and as often as the GOFERR, the U.S. Department of Treasury or OMB shall demand, the Grantee shall make available to the GOFERR, the U.S. Department of Treasury or OMB all records pertaining to matters covered by this Agreement. The Grantee shall permit the GOFERR, the U.S. Department of Treasury or OMB to audit, examine, and reproduce such records, and to make audits of all contracts, invoices, materials, payrolls, personnel records, data, and other information relating to all matters covered by this Agreement. As used in this paragraph, "Grantee" includes all persons, natural or fictional, affiliated with, controlled by, or under common ownership with, the entity identified as the Grantee in Paragraph 1.3 of these provisions.

#### 7. PERSONNEL.

The Grantee shall, at its own expense, provide all personnel necessary to perform the Grant. The Grantee warrants that all personnel engaged in the Grant shall be qualified to perform such Grant, and shall be properly licensed and authorized to perform such Grant under all applicable laws. Grantee shall comply with all GOFERR and federal personnel and labor laws applicable to its employees.

The Grant Officer shall be the representative of the State hereunder. In the event of any dispute hereunder, the interpretation of this Agreement by the Grant Officer, and his/her decision on any dispute, shall be final.

8. CONDITIONAL NATURE OF AGREEMENT. Notwithstanding anything in this Agreement to the contrary, all obligations of the GOFERR hereunder, including, without limitation, the continuance of payments hereunder, are contingent upon the availability or continued appropriation of funds, and in no event shall the GOFERR be liable for any payments hereunder in excess of such available or appropriated funds. In the event of a reduction or termination of those funds, the GOFERR shall have the right to withhold payment until such funds become available, if ever, and shall have the right to terminate this Agreement immediately upon giving the Grantee notice of such termination.

#### 9. EVENT OF DEFAULT: REMEDIES.

Any one or more of the following acts or omissions of the Grantee shall constitute an event of default hereunder (hereinafter referred to as "Events of Default"):

Failure to perform the Grant satisfactorily or on schedule;

Failure to submit any report required hereunder;

Failure to maintain, or permit access to, the records required hereunder; or

Failure to perform any of the other covenants and conditions of this Agreement.

Upon the occurrence of any Event of Default, the GOFERR may take any one, or more, or all, of the following actions:

Give the Grantee a written notice specifying the Event of Default and requiring it to be remedied within, in the absence of a greater or lesser specification of time, thirty (30) days from the date of the notice; and if the Event of Default is not timely remedied, terminate this Agreement, effective two (2) days after giving the Grantee notice of termination; and

Give the Grantee a written notice specifying the Event of Default and suspending all payments to be made under this Agreement and ordering that the portion of the Grant Amount which would otherwise accrue to the Grantee during the period from the date of such notice until such time as the GOFERR determines that the Grantee has cured the Event of Default shall never be paid to the Grantee;

Set off against any other obligation the GOFERR may owe to the Grantee any damages the GOFERR suffers by reason of any Event of Default;

Recoup from the Grantee, including by withholding any other payment of funds that becomes due to Grantee from the GOFERR, any payments under this Agreement that have been used in a manner contrary to the terms of this Agreement or H.R. 133, Section 501(c) Division N; and/or

Treat the Agreement as breached and pursue any of its remedies at law or in equity, or both.

#### 10. TERMINATION.

In the event of any early termination of this Agreement for any reason other than the completion of the Grant, the Grantee shall deliver to the Grant Officer, not later than fifteen (15) days after the date of termination, a report (hereinafter referred to as the "Termination Report") describing in detail all Grant expenses reimbursed, and the Grant Amount earned, to and including the date of termination.

In the event of Termination under paragraph 9 of these general provisions, the approval of such a Termination Report by the GOFERR shall entitle the Grantee to retain the portion of the Grant amount carned up to and including the date of termination.

The approval of such a Termination Report by the GOFERR shall in no event relieve the Grantee from any and all liability for damages sustained or incurred by the GOFERR as a result of the Grantee's breach of its obligations hereunder.

Notwithstanding anything in this Agreement to the contrary, either the GOFERR or, except where notice default has been given to the Grantee hereunder, the Grantee, may terminate this Agreement without cause upon thirty (30) days written notice.

11. CONFLICT OF INTEREST. No officer, member or employee of the Grantee, and no representative,

officer or employee of the State of New Hampshire or of the governing body of the locality or localities in which the Grant is to be performed, who exercises any functions or responsibilities in the review or approval of the undertaking or carrying out of such Grant, shall participate in any decision relating to this Agreement or the proceeds thereof which affects his or her personal or pecuniary interest or the interest of any corporation, partnership, or association in which he or she is directly or indirectly interested.
