

EXPLANATION

The Department of Employment Security (NHES), Economic and Labor Market Information (ELMI) Bureau is requesting authorization to accept and expend \$60,000 from the Department of Health and Human Services (DHHS), to conduct an economic analysis of the "cliff effect" across New Hampshire. The cliff effect describes what happens when wages alone do not equally make up for the loss of public benefits for working families. The analysis is to be conducted by NHES ELMI Bureau, in partnership with technical experts from DHHS, in order to better understand the wage and benefits dynamics on a statewide level as well as the unique challenges within each region. This analysis will then help to build the foundation from which informed policy recommendations can be developed in order to mitigate and possibly eliminate disincentives and barriers to employment.

NHES is requesting authorization to accept and expend \$20,000 in funds from DHHS, for NHES staffing related costs for conducting the analysis and then the remaining \$40,000 in funds from DHHS is reserved to contract with a private vendor to build upon the work done by NHES and make policy recommendations for moving forward. This contract would involve a competitive request for proposals process and would be submitted to Governor & Council for consideration.

NHES is requesting authorization to accept and expend \$60,000 in funds from DHHS, and to budget the funds as follows:

Class 020 Current Expenses will be used to support the portion of operating costs associated with the positions involved in the project.

Class 022 Rentals will be used to support the portion of operating costs associated with the positions involved in the project.

Class 023 Utilities will be used to support the portion of operating costs associated with the positions involved in the project.

Class 024 Maintenance, Other than Building & Grounds will be used to support the portion of operating costs associated with the positions involved in the project.

Class 038 Technology - Software will be used to support the portion of operating costs associated with the positions involved in the project.

Class 039 Telecommunications will be used to support the portion of operating costs associated with the positions involved in the project.

Class 048 Maintenance, Building & Grounds will be used to support the portion of operating costs associated with the positions involved with the project.

Class 050 Personal Services – Part Time will be used to support a portion of two (2) existing full-time permanent staff involved in the project.

Class 060 Benefits will be used to cover the benefits cost associated with the positions involved in the project.

Class 102 Contracts for Program Services will be used to support a contract with a private vendor to build upon the work done by NHES for the project.

Class 103 Contracts for Operational Services will be used to support the portion of operating costs associated with the positions involved with the project.
