REQUESTED ACTION

Pursuant to RSA 4:39-c and 228:31, AUTHORIZE the Department of Transportation to sell a 2,050 +/-square foot parcel of State owned land located on the northerly side of US Route 302 in the Town of Littleton to Michael Bijolle for fourteen thousand one hundred (\$14,100.00) dollars which includes a one thousand one hundred (\$1,100.00) dollar Administrative Fee, with the condition that Michael Bijolle agrees to formally deed to the Department his access rights to US Route 302 from his abutting parcel as shown on Littleton Tax Map 77, Lot 11, effective upon Governor and Executive Council approval.

It has been determined by the Division of Finance that this parcel was originally purchased with 75% Federal Funds and 25% Highway Funds.

EXPLANATION

The Department of Transportation has received a request from an abutter, Michael Bijolle, for the opportunity to acquire a parcel of State owned land consisting of 2,050 +/- square feet located on the northerly side of US Route 302 in the Town of Littleton.

The parcel consists of approximately 2,050 +/- square feet and was acquired in 1990 in conjunction with the reconstruction of US Route 302 through this area as part of the Littleton RS-204(3), P-3623 project.

When the project to reconstruct US Route 302 was done in 1990, this project took away the parking for Michael Bijolle's property. It was agreed as part of the project that the Department would enter into an Encroachment Agreement with Michael Bijolle that would allow him to utilize this subject State owned parcel as parking for his property, which is an apartment house. In return, Michael Bijolle would have the two driveways that service his property removed.

Michael Bijolle has contacted the Department requesting to acquire the adjacent State owned parcel. The Department would propose to sell this parcel directly to Michael Bijolle with the condition that in addition to selling him this parcel at fair market value, Michael Bijolle would agree to formally deed to the Department his access rights to US Route 302 from his abutting parcel as shown on Littleton Tax Map 77, Lot 11.

This request has been reviewed by this Department and it has been determined that this parcel is surplus to our operational needs and interest.

Approval of the sale of this property by the Council of Resources and Development is no longer necessary per RSA 4:39-c whereas the parcel to be sold was purchased with Highway Funds.

The Long Range Capital Planning and Utilization Committee at their May 27, 2015 meeting approved this request that the Department should enter into a direct sale with Michael Bijolle and sell this parcel for \$14,100.00 which includes an Administrative Fee of \$1,100.00 with the condition that Michael Bijolle agrees to formally deed to the Department his access rights to US Route 302 from his abutting parcel as shown on Littleton Tax Map 77, Lot 11.

In accordance with RSA 4:39-c, the Town of Littleton has been offered this property at the approved purchase price and they did not express an interest in purchasing the property.

Authorization is respectfully requested to sell this parcel to Michael Bijolle, as outlined above.
