EXPLANATION

Approval of this request will enable the State to continue receiving support in the Department's efforts to improve the quality of laboratory practices and health outcomes.

All states are members of American Public Health Association. The Department of Health and Human Services, Division of Public Health, Public Health Laboratories, is the sole New Hampshire state agency that is a member.

4. How is the dues structure established? (Standard fee for all states, based on population, based on other criteria, etc.)

The American Public Health Association Board of Directors determines the annual dues for States based on population.

5. What benefit does the state receive from participating in this membership?

The American Public Health Association provides:

- Staff in Washington, DC to advocate for national issues of public health and public health laboratory significance. For small states such as New Hampshire that do not have a Washington, DC office, American Public Health Association legislative staff provide timely briefings to state laboratory officials on congressional activities, and non-partisan advocacy on public health issues, such as funding for laboratory emergency response, infectious disease control, and disease outbreaks such as COVID-19. Given that more than half of the public health laboratories' operating budget comes from federal sources, the Department's participation with the American Public Health Association is vital to maintain our ability to continue to receive federal grants and funding for these programs.
- Technical support and assistance with applying for and obtaining federal grants that assist the laboratory with the development and implementation of its strategic priorities. The American Public Health Association provides supplemental funding for these priorities, such as funding to implement rapid molecular testing for tuberculosis.
- Funding for trainings and national meetings as well as webinar training and "handson" laboratory training for a variety of public health laboratory topics including measles testing, molecular virology testing, and laboratory biosafety.
- Direct funding for travel and training for laboratory staff through its Emerging Laboratory Leadership Program.

The American Public Health Association serves as a clearinghouse for state public health laboratories to confidentially share best practices with each other and to provide training and information to administrative staff on topics that include laboratory efficiency initiatives, funding, improving procurement strategies, and advocating for public health laboratories.

The American Public Health Association facilitates the prompt dissemination of information to public health laboratories by coordinating conference calls and meetings between subject matter experts at the Centers for Disease Control and Prevention and public health laboratories.

6. Are training or educational/research materials included in the membership? If so, is the cost included? Explain in detail.

Yes. The American Public Health Association provides educational webinars at no additional cost to members. The American Public Health Association provides funding for travel, hotels and all training costs associated with technical laboratory-specific educational trainings.
