**REQUESTED ACTION**

Authorize the Department of Justice to accept and expend \$26,556 from the U.S. Department of Justice, Bureau of Justice Assistance, Office of Justice Programs, Residential Substance Abuse Treatment (RSAT) Program to be utilized to provide substance abuse treatment for prisoners in the state prison and county jails, effective upon approval of the Governor and Executive Council through June 30, 2021. 100% Federal Funds.

The RSAT program is a federal formula grant program from the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance. Its purpose is to assist states and units of local government to establish and maintain residential substance abuse treatment programs in correctional and detention facilities where adult and juvenile offenders are incarcerated for a sufficient period of time to permit substance abuse treatment.

The Department of Justice will grant RSAT funds, through a competitive application process, to participating correctional facilities in the state that offer substance abuse treatment to incarcerated individuals.

In the event that federal funds become no longer available, general funds will not be requested to support this program.

**1. Requirements of the award; remedies for non-compliance or for materially false statements**

The conditions of this award are material requirements of the award. **9. Employment eligibility verification for hiring under the award**

any person or other entity, to violate any federal law, including any applicable civil rights or nondiscrimination law.

E. Nothing in this condition, including in paragraph 4.B., shall be understood to relieve any recipient, any subrecipient at any tier, or any person or other entity, of any obligation otherwise imposed by law, including 8 U.S.C. 1324a(a)(1) and (2).

**13. Unreasonable restrictions on competition under the award; association with federal government**

B. Nothing in this condition shall be understood to authorize or require any recipient, any subrecipient at any tier, or any person or other entity, to violate any federal law, including any applicable civil rights or nondiscrimination law.
