EXPLANATION

The University Of New Hampshire (UNH) received funds from the United States Department of Agriculture (USDA) to conduct risk management and crop insurance education programs in New Hampshire. UNH has granted a portion of these funds to NHDAMF to develop and publish an informational article series, manage a section of the NHDAMF website pertaining to risk management information of interest to the New Hampshire agriculture industry and coordinate organic risk management workshops.

The following appropriation authority is being requested for Fiscal Year 2019:

Class 040 & 041 – Indirect & Audit Fees – FY 19 \$3,849. Calculated at allowed 14.45% of awarded grant funds.

Class 069 – Promotional Marketing – FY 19 \$12,500. These additional funds will be used to pay for marketing to promote the program.

Class 102 – Contracts for Program Services – FY 19 \$10,229. These additional funds will be used to pay for program expenses to perform the necessary.

In the event that these funds become no longer available, general funds will not be requested to support this program.
