#### **EXPLANATION**

The Department of Education, Office of Nutrition Programs and Services administers the United States Department of Education Child Nutrition Programs. These programs offer families in New Hampshire affordable school, after school, summer and child care meals at either a free, reduced or paid status. The Department of Education must provide regulatory training for food service professionals, administrators and directors regarding the regulations in the Federal Child Nutrition Programs. It is only with technical assistance and training that our schools and institutions can be successful and knowledgeable in order to provide children with healthful meals to give them the necessary nutrients their bodies and brains need to be ready to learn and to succeed.

The Tri State Conference allows each of the three states (Maine, Vermont and New Hampshire), the ability to train all attendees in non-state specific regulations found in the federal program. In addition, it gives the participants the ability to interact with one another and to exchange best practices in the child nutrition programs.

Proposals were requested from the Grand Summit Hotel at Attitash, North Conway Grand Hotel, Red Jacket Inn, Omni Mount Washington Resort, Hampshire Hospitality Holdings, LLC dba Mill Falls, Meredith. All these establishments are located in an area of New Hampshire that is easily accessible by all three States and each facility could handle the numbers of participants.

The Department received a proposal from: the Grand Summit at Attitash in the amount of \$3,300.00. Another was received from the Omni Mount Washington Resort in the amount of \$6,500.00. Hampshire Hospitality Holdings, LLC dba Mill Falls at the Lake in Meredith was selected since it offered the lowest price of \$2,195.00 and met the required meeting space to accommodate the program.

In the event federal funds become no longer available, general funds will not be requested to support this event.
