

BOARD OF AUCTIONEERS MINUTES

October 7, 2013, 9:00 a.m.

1. The Board of Auctioneers convened at 9:00 a.m. with, Chairman Russell R. Abbott, Vice-Chairman Roy W. Tilsley, Secretary Gregory J. Walsh, Member Robert P. Secord, and Member Richard C. Berman present.
2. The Board on motion of Roy W. Tilsley, seconded by, Gregory J. Walsh accepted the minutes of the September 9, 2013 meeting.
3. The Board on motion of Roy W. Tilsley, seconded by Gregory J. Walsh, authorized the application of Garrett D. Healey for an Auctioneers License.
