REQUESTED ACTION

Authorize the Department of Environmental Services (NHDES) to pay membership dues to the Association of State Dam Safety Officials (Vendor Code# 171855-B001), Lexington, KY in the amount of \$2,960.00, for the period of October 1, 2021 through September 30, 2022, effective upon Governor and Council approval. 100% Fee Funds.

EXPLANATION

NHDES and previously one of its predecessor agencies, the New Hampshire Water Resources Board, has been a member of the Association of State Dam Safety Officials (ASDSO) since it was founded in 1983. ASDSO is a national non-profit organization of state and federal dam safety regulators, dam owners and operators that provides a strong, unified voice and effective programs and policies toward the furtherance of dam safety in the states. The voting members of the Association are the fifty (50) states.

ASDSO membership provides a benefit to New Hampshire's Dam Safety Program through the following:

- Improving the efficiency and effectiveness of state dam safety programs;
- Bringing dam safety to a higher level of awareness among the general public, state and federal legislatures, specific organizations and other stakeholders;
- Keeping Congress informed on key issues related to dam safety, including appropriations, new legislation, and program efficiency and effectiveness;
- Informing states about federal and state dam safety activities;
- Providing technical training opportunities to the states;
- Providing leadership through facilitation of inter-organizational, intergovernmental and interstate cooperation;
- Strengthening the dam safety community and providing a forum for the exchange of information; and
- Providing quality outreach programs for dam owners/operators, members and non-members, about the need to maintain safe dams.

Listed below are answers to the standard questions required for submissions to the Governor and Council for approval of organization dues and membership:

1. **How long has this organization been in existence and how long has this agency been a member of this organization?** The organization was founded in 1983. NHDES and previously one of its predecessor agencies, the New Hampshire Water Resources Board, has been a member since the organization was founded.
2. **Is there any other organization which provides the same or similar benefits which your agency belongs to?** No. This is the only national organization to which NHDES belongs that is dedicated to furthering dam safety in the states and supporting and providing state input on national policy issues and funding under the federal Dam Safety Act and the federal High Hazard Potential Rehabilitation Grant Program.
3. **How many other states belong to this organization and is your agency the sole New Hampshire state agency that is a member?** All fifty states and Puerto Rico belong to this organization. NHDES is the sole New Hampshire state agency that is a member.
4. **How is the dues structure established? (Standard fee for all states, based on population, based on other criteria, etc.).** The fifty states make up the voting membership of the Association, and there is a standard fee for all states.
5. **What benefit does the state receive from participating in this membership?** Membership in ASDSO has improved New Hampshire's dam safety program. ASDSO has performed a Peer Review of New Hampshire's Dam Safety Program, at no cost to the state, to evaluate the competence of the program relative to the generally accepted standards of practice in dam safety. In addition, ASDSO's work with Congress and Federal Emergency Management Agency (FEMA) has been instrumental in providing training and direct funding to New Hampshire to improve the safety of dams in the state. ASDSO works closely with Congress to ensure reauthorization of the National Dam Safety Program Act. Under the National Dam Safety Program, FEMA provides \$500,000 for training of state dam safety engineers, much of it through ASDSO. Each year, NHDES has sent engineers multiple times to courses on dam safety at FEMA's training center, with tuition, travel and lodging expense fully reimbursed by FEMA under this program. Also, the National Dam Safety Program provides grants to improve state dam safety programs, under which New Hampshire receives over \$90,000 each year and could increase to over \$500,000 per year with passage of the Infrastructure and Jobs Act, as a result of ASDSO's involvement in the drafting of this legislation. Lastly, ASDSO's work with Congress and FEMA has resulted in the establishment of FEMA's High Hazard Dam Rehabilitation Grant Program, which last year provided New Hampshire over \$400,000 each year over the past two years to be used for the rehabilitation of high hazard dams in the state, which could increase to \$4 million per year over the next five years if the Infrastructure Investment and Jobs Act passes.
6. **Are training or educational/ research materials included in the membership? If so, is the cost included? Explain in detail.** Membership includes a subscription to a monthly newsletter and the

quarterly Journal of Dam Safety. The Journal consists of articles on lessons learned and new technology in dam safety engineering. In addition, the Association has an annual national conference, which is one of the leading conferences in the United States dedicated to dam safety engineering and technology transfer. The dues that New Hampshire pays, provides for one complimentary annual conference registration. In addition, ASDSO sponsors regional conferences and several technical seminars each year on the topics of dam safety, including the computer modeling of dam failure floods, hydrologic analysis, hydraulic design, geotechnical engineering, structural analysis and design, construction techniques, and causes of dam failures. This training is critical to our dam safety engineers to provide them with the specialized training needed for them to properly, inspect, design and review and approve plans and specifications of the more than 2,600 dams in the State, as well as model the downstream flooding due to dam failure in order to classify the dams. Under New Hampshire's membership, NHDES Dam Bureau staff receives a 15 to 20 percent discount at all technical seminars. Because of New Hampshire's leadership in ASDSO, New Hampshire hosted the ASDSO Northeast Regional Conference in Manchester, which was attended by over 200 people. In addition, New Hampshire was the site of an ASDSO technical seminar on hydraulic modeling with applications to dam safety.

- 7. Is the membership required to receive any federal grants or required in order to receive or participate in licensing or certification exams? Explain. No.**
- 8. Is there any travel included with this membership fee? Explain in detail any travel to include the number of employees involved, the number of trips, destination if known and purposes of membership supported trips. None.**
- 9. Which state agency employees are directly involved with this organization? (Indicate if they are members, voting members, committee members, and/or officers of the organization.)** James Gallagher, Administrator of the NHDES Dam Bureau, is a voting member of the Association. In the past, he has also served on the Board of Directors and has been an association officer in a number of positions, including president. In addition to Mr. Gallagher, the Dam Bureau staff receives the benefits of membership, previously described, as a result of the dues that New Hampshire pays to the Association.
- 10. Explain in detail any negative impact to the State if the Agency did not belong to this organization.** If NHDES did not belong to the Association, New Hampshire would not be as fully informed on national dam safety issues being debated in Congress and considered by federal agencies including FEMA, the Department of Homeland Security, the Army Corps of Engineers and the Natural Resources Conservation Service. New Hampshire would also not have the ability to regularly provide direct input, in close coordination with other national leaders from the other 50 state dam safety offices, on national dam safety policy, legislation proposed in Congress, and the impacts of federal budget decisions on the New Hampshire dam safety program. Membership in ASDSO has historically enabled NHDES to provide significant, timely input on national dam safety policy to Congress that has had positive effects. The ability to provide state-specific input, and to leverage our impact through an association that represents all 50 states, on the decisions of Congress and federal agencies relative to complex dam safety issues would be very substantially

reduced, and this would be to the detriment of the State. Additional negative impacts would include a reduction in access to the wealth of training opportunities and educational and research material that the Association provides its members.

In summary, ASDSO is an outstanding organization with very active participation by New Hampshire from which we gain a significant return on our investment in dues. Active support and involvement in this organization by payment of these dues is good value for the State of New Hampshire.
