REQUESTED ACTION

Authorize the Department of Administrative Services to enter into a **sole source** amendment to a current contract with Powerhouse Equipment & Engineering Co., Inc., (vc# 277569) Delanco, NJ for portable steam boiler rental services, originally approved by Governor and Executive Council on April 11, 2018 (item #106), first amendment on March 13, 2019 (item #107), second amendment on May 1, 2019 (item #78) and third amendment on December 18, 2019 (item # 197) by extending the completion date from January 31, 2020 to April 30, 2020 and increasing the contract amount by \$99,840 from \$836,820 to \$936,660. This contract amendment shall be effective upon Governor and Council approval. **100% General Funds**

The cost of the contract amendment shall be paid contingent upon availability and continued appropriation through various individual Department of Administrative Services budgeted utility line expenditures.

EXPLANATION

The temporary steam boilers are located at the Department of Justice parking lot and they provide steam heat to the State House, State Library and State House Annex. Our third contract amendment to rent these portable steam boilers ends on January 31, 2020. We are currently utilizing the new permanent boiler plant and steam distribution system and we have the temporary steam boilers on stand by while we work out a few minor problems with the new plant. As a result, we are requesting approval of a month-to-month agreement that automatically renews with a not to exceed completion date of April 30, 2020. This will provide us with sufficient time to have a successful transition to the permanent heating system and decommission the temporary boilers and infrastructure.

Fourth Contract Amendment Temporary Steam Boiler Rental Services

It is hereby agreed that the contract approved by NH Governor and Council on April 11, 2018, the first amendment approved by NH Governor and Council on March 13, 2019, the second amendment approved by NH Governor and Council on May 1, 2019 and the third amendment approved by NH Governor and Council on December 18, 2019, between Powerhouse Equipment & Engineering Co., Inc., as "Contractor" and the Department of Administrative Services as "State", for temporary steam boiler rental services in Concord, is amended as follows:

- 1. Delete in its entirety section 1.7 Completion Date and substitute therefore the following:
 - 1.7 Completion Date Not to Exceed April 30, 2020
- 2. Delete in its entirety section 1.8 Price Limitation and substitute therefore the following:
 - 1.8 Price Limitation \$936,660
- 3. Delete in its entirety Exhibit A, Paragraph 1 and substitute therefore the following:
 - 1. The Contractor shall provide "temporary steam boiler rental services" for two 500 h.p. steam boilers located at 33 Capitol Street.
- 4. Delete in its entirety Exhibit A, Paragraph 2 and substitute therefore the following:
 - 2. The term of this contract shall begin with NH Governor and Council approval and shall be on a monthly basis not to exceed April 30, 2020. The rental of the temporary steam boilers shall automatically renew on a monthly basis at the rate set forth in Exhibit B. The monthly rental can be terminated at any time during the contract term by providing the Contractor a written notice at least fourteen (14) calendar days in advance.
- 5. Delete in its entirety Exhibit B, paragraph 1 and substitute therefore the following:
 - 1. The Contractor hereby agrees to provide "temporary steam boiler rental services; for a not to exceed price of \$936,660 for the period commencing upon Governor and Council approval through April 30, 2020 (herein after referred to as the contract price) in return for the services described in Exhibit "A."
- 6. Delete in its entirety Exhibit B, paragraph 2 and substitute therefore the following:
 - 2. The steam boiler rates are as follows:

\$16,640 per boiler per month.



This contract was originally approved by Governor and Executive Council on April 11, 2018 (item #106), with the first amendment approved on March 13, 2019 (item #107) and a second amendment on May 1, 2019 (item #78). This contract amendment shall be effective upon Governor and Council approval. **100% General Funds**

The cost of the contract amendment shall be paid contingent upon availability and continued appropriation through various individual Department of Administrative Services budgeted utility line expenditures.

EXPLANATION

The temporary steam boilers are located at the Department of Justice parking lot and they provide steam heat to the State House, State Library and State House Annex. We are in the process of constructing a new permanent steam boiler building and steam distribution system. The new permanent steam boilers are scheduled to be on line shortly. Our second contract amendment to rent portable steam boilers ends on December 31, 2019. We are requesting one additional month to allow enough time for the new permanent steam plant to be fully functional and put out a bid and obtain approval from Governor and Council for a new contract to remove the temporary boiler



REQUESTED ACTION

Authorize the Department of Administrative Services to enter Info a retroactive sale source contract with Powerhouse Equipment & Engineering Co., Inc., (vc# 277569) Delanca; NJ for a total price not to exceed \$499,430 to rent portable steam boiler systems. Upon Governor and Council approval, the contract will be effective from April 1, 2018 through April 30, 2019.

The cost for the contract shall be paid monthly with \$49,920 being paid in FY 2018 and the balance of \$449,510 in FY 19, contingent upon availability and continued appropriations through various individual Department of Administrative Services budgeted utility line expenditures.

EXPLANATION.

This contract is sale source because we need to stay with the same company that is currently providing the rental boilers. The temporary sleam boilers are connected to the utility intrastructure and the cost to disconnect, modify and reconnect the related infrastructure would be cost prohibitive. This request is retroactive because we were waiting to determine the bid results and proposed schedule for the permanent heating schedule for the State House Complex which will be underway shortly.

This contract is required to provide temporary heating for 14 state owned facilities located in Cancord, NH that previously obtained steam from Concord Steam. Concord Steam closed on May 31, 2017. The State entered into an agreement with Liberty Utilities (EnergyNorth Natural Gos) Corp. approved by Governor and Council on May 17, 2017, Item #79 to install temporary steam boller systems to provide temporary heat to state facilities to give the Department of Administrative Services time to design, bid and contract to install permanent heating systems for 26 state owned facilities. Utberty Utilities entered into a contract on behalf of the Department of Administrative Services with Powerhouse Equipment and Engineering Co., Inc., to provide four temporary steam boilers. Two boilers are located at the State Office Park South and two boilers are located at the Department of Justice parking lot.

The term of one of the steam boilers located at the Department of Justice parking lot ends on March 31, 2018. The remaining three boilers contract terminates on October 28, 2018. This contract is required to continue to rent these same boilers until March 31, 2019. At that time we anticipate that all the permanent heating systems will be installed and functional.

- 2. EMPLOYMENT OF CONTRACTOR/SERVICES TO BE PERFORMED. The State of New Hampshire, acting through the agency identified in block 1.1 ("State"), engages contractor identified in block 1.3 ("Contractor") to perform, and the Contractor shall perform, the work or sale of goods, or both, identified and more particularly described in the attached EXHIBIT A which is incorporated herein by reference ("Services").
- 3.1 Notwithstanding any provision of this Agreement to the contrary, and subject to the approval of the Governor and Executive Council of the State of New Hampshire, if applicable, this Agreement, and all obligations of the parties hereunder, shall become effective on the date the Governor and Executive Council approve this Agreement as indicated in

3. EFFECTIVE DATE/COMPLETION OF SERVICES.

block 1.18, unless no such approval is required, in which case the Agreement shall become effective on the date the Agreement is signed by the State Agency as shown in block 1.14 (Fffertive Date*).

1.14 ("Effective Date").

3.2 If the Contractor commences the Services prior to the Effective Date, all Services performed by the Contractor prior to the Effective Date shall be performed at the sole risk of the Contractor, and in the event that this Agreement does not become effective, the State shall have no liability to the Contractor, including without limitation, any obligation to pay the Contractor for any costs incurred or Services performed. Contractor must complete all Services by the Completion Date specified in block 1.7.

4. CONDITIONAL NATURE OF AGREEMENT. Notwithstanding any provision of this Agreement to the contrary, all obligations of the State hereunder, including, without limitation, the continuance of payments hereunder, are contingent upon the availability and continued appropriation of funds, and in no event shall the State be liable for any payments hereunder in excess of such available appropriated funds. 5.2 The payment by the State of the contract price shall be the only and the complete reimbursement to the Contractor for all expenses, of whatever nature incurred by the Contractor in the performance hereof, and shall be the only and the complete compensation to the Contractor for the Services. The State shall have no liability to the Contractor other than the contract price.

5.3 The State reserves the right to offset from any amounts otherwise payable to the Contractor under this Agreement those liquidated amounts required or permitted by N.H. RSA 80:7 through RSA 80:7-c or any other provision of taw.

5.4 Notwithstanding any provision in this Agreement to the contrary, and notwithstanding unexpected circumstances, in no event shall the total of all payments authorized, or actually made bereunder, exceed the Price Limitation set forth in block 1.8.

6. COMPLIANCE BY CONTRACTOR WITH LAWS AND REGULATIONS/ EQUAL EMPLOYMENT OPPORTUNITY.

6.1 In connection with the performance of the Services, the Contractor shall comply with all statutes, laws, regulations, and orders of federal, state, county or municipal authorities which impose any obligation or duty upon the Contractor, including, but not limited to, civil rights and equal opportunity laws. This may include the requirement to utilize auxiliary aids and services to ensure that persons with communication disabilities, including vision, hearing and speech, can communicate with, receive information from, and convey information to the Contractor. In addition, the Contractor shall comply with all applicable copyright laws. 6.2 During the term of this Agreement, the Contractor shall not discriminate against employees or applicants for employment because of race, color, religion, creed, ege, sex, handicap, sexual orientation, or national origin and will take affirmative action to prevent such discrimination. 6.3 If this Agreement is funded in any part by monies of the United States, the Contractor shall comply with all the provisions of Executive Order No. 11246 ("Equal Employment Opportunity"), as supplemented by the regulations of the United States Department of Labor (4) C.F.R. Part 60), and with any rules, regulations and guidelines as the State of New Hampshire or the United States issue to implement these regulations. 7. PERSONNEL

- 7.1 The Contractor shall at its own expense provide all personnel necessary to perform the Services. - 7.2 Unless otherwise authorized in writing, during the term of this Agreement, and for a period of six (6) months after the Completion Date in block 1.7, the Contractor shall not hire, and shall not permit any subcontractor or other person, firm or corporation with whom it is engaged in a combined effort to perform the Services to hire, any person who is a State employed or official; who is materially involved in the iprocurement, administration or performance of this

7.3 The Contracting Officer specified in block 1.9, or his or her successor, shall be the State's representative. In the event of any dispute concerning the interpretation of this Agreement, the Contracting Officer's decision shall be final for the State.

8. EVENT OF DEPAULT/REMEDIES.

- 8.1 Any one or more of the following acts or emissions of the Contractor shall constitute an event of default hereunder ("Event of Default"):
- 8.1.1 Tailure to perform the Services satisfactorily or on schedule;
- 8.1.2 failure to submit any report required hereunder; and/or 8.1.3 failure to perform any other covenant, term or condition of this Agreement:
- 8.2 Upon the occurrence of any Event of Default, the State may take any one, or more, or all, of the following actions:
 8.2.1 give the Contractor a written notice specifying the Event of Default and requiring it to be remedied within, in the absence of a greater or lesser specification of time, thirty (30) days from the date of the notice; and if the Event of Default is not timely remedied, terminate this Agreement, effective two (2) days after giving the Contractor notice of termination;
- 8.2.2 give the Contractor a written notice specifying the Event of Default and suspending all payments to be made under this Agreement and ordering that the portion of the contract price which would otherwise accrue to the Contractor during the period from the date of such notice until such time as the State determines that the Contractor has cured the Event of Default shall never be paid to the Contractor;
- 8.2.3 set off against any other obligations the State may owe to the Contractor any damages the State suffers by reason of any Event of Default; and/or
- 8.2.4 treat the Agreement as breached and pursue any of its remedies at law or in equity, or both.

9. DATA/ACCESS/CONFIDENTIALITY/PRESERVATION.

- 9.1 As used in this Agreement, the word "data" shall mean all information and things developed or obtained during the performance of, or acquired or developed by reason of, this Agreement, including, but not limited to, all studies, reports, files, formulae, surveys, maps, charts, sound recordings, video recordings, pictorial reproductions, drawings, analyses, graphic representations, computer programs, computer primouts, notes, letters, memoranda, papers, and documents, all whether finished or unfinished.
- 9.2 All data and any property which has been received from the State or purchased with funds provided for that purpose under this Agreement, shall be the property of the State, and shall be returned to the State upon demand or upon termination of this Agreement for any reason.
- 9.3 Confidentiality of data shall be governed by N.H. RSA chapter 91-A or other existing law. Disclosure of data requires prior written approval of the State.

- 10. TERMINATION. In the event of an early termination of this Agreement for any reason other than the completion of the Services; the Contractor shall deliver to the Contracting. Officer, not later than fifteen (15) days after the date of termination, a report ("Termination Report") describing in detail all Services performed, and the contract price earned, to and including the date of termination. The form, subject matter, content, and number of copies of the Termination Report shall be identical to those of any Final Report described in the attached EXHIBIT A.
- 11. CONTRACTOR'S RELATION TO THE STATE. In the performance of this Agreement the Contractor is in all respects an independent contractor, and is neither an agent nor an employee of the State. Neither the Contractor nor any of its officers, employees, agents or members shall have authority to bind the State or receive any benefits, workers' compensation or other emoluments provided by the State to its employees.
- 12. ASSIGNMENT/DELEGATION/SUBCONTRACTS.
 The Contractor shall not assign, or otherwise transfer any interest in this Agreement without the prior written notice and consent of the State. None of the Services shall be subcontracted by the Contractor without the prior written notice and consent of the State.
- 13. INDEMNIFICATION. RSA chapter 281-A, Contractor shall maintain, and require any subcontractor or assignee to secure and maintain, payment of Workers' Compensation in connection with activities which the person proposes to undertake pursuant to,this Agreement. Contractor shall furnish the Contracting Officer identified in block 1.9, or his or her successor, proof of Workers' Compensation in the manner described in N.H. RSA chapter 281-A and any applicable renewal(s) thereof, which shall be attached and are incorporated herein by reference. No failure by the State to enforce any provisions hereof after any Event of Default shall be deemed a waiver of its rights with regard to that Event of Default, or any subsequent Event of Default. No express failure to enforce any Event of Default shall be deemed a waiver of the right of the State to enforce each and all of the provisions hereof upon any further or other Event of Default on the part of the Contractor.
- 17. NOTICE. Any notice by a party hereto to the other party shall be deemed to have been duly delivered or given at the time of mailing by certified mail, postage prepaid, in a United States Post Office addressed to the parties at the addresses given in blocks 1.2 and 1.4, herein.
- 18. AMENDMENT. This Agreement may be amended, waived or discharged only by an instrument in writing signed by the parties hereto and only after approval of such amendment, waiver or discharge by the Governor and Executive Council of the State of New Hampshire unless no

such approval is required under the circumstances pursuant to State law, rule or policy.

- 19. CONSTRUCTION OF AGREEMENT AND TERMS. This Agreement shall be construed in accordance with the laws of the State of New Hampshire, and is binding upon and inures to the benefit of the parties and their respective successors and assigns. The wording used in this Agreement is the wording chosen by the parties to express their mutual intent, and no rule of construction shall be applied against or in favor of any party.
- 20. THIRD PARTIES. The parties hereto do not intend to benefit any third parties and this Agreement shall not be construed to confer any such benefit.
- 21. HEADINGS. The licadings throughout the Agreement are for reference purposes only; and the words contained therein shall in no way be held to explain, modify, amplify or aid in the interpretation, construction or meaning of the provisions of this Agreement.
- 21. SPECIAL PROVISIONS. Additional provisions set forth in the attached EXCHBIT C are incorporated herein by reference.
- 23. SEVERABILITY. In the event any of the provisions of this Agreement are held by a court of competent jurisdiction to be contrary to any state or federal law, the remaining provisions of this Agreement will remain in full force and effect.
- 24. ENTIRE AGREEMENT. This Agreement, which may be executed in a number of counterparts, each of which shall be deemed an original, constitutes the entire Agreement and understanding between the parties, and supersedes all prior Agreements and understandings relating hereto.
