REQUESTED ACTION

1. Authorize the Department of Transportation to enter into a contract with Pike Industries, Inc. of Belmont, NH (Vendor 177300) on the basis of a low bid of \$6,393,237.13 for pavement resurfacing on a section of I-93 southbound in Manchester and Hooksett in District 5 at Exits 6, 7, 8, 9 and 10 (Project: Manchester-Hooksett 43071) from the date of Governor and Council approval through September 29, 2023, unless extended by the Department in accordance with the Standard Specifications. 100% Federal Funds.

Funding is available in State Fiscal Years 2022 and 2023, and is contingent upon the availability and continued appropriation of funds in Fiscal Year 2024 as follows, with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:

2. Further authorize that a contingency in the amount of \$319,661.86 be approved for payment of latent conditions, which may appear during the construction of the project. The contingency requested is 5% of the contract amount.

EXPLANATION

This project is part of the State's Ten-Year Transportation Improvement Plan, under the PAVE-Tier 1-Resurfacing. This project involves 12.4 miles of pavement resurfacing on a section of I-93 in the City of Manchester and the Town of Hooksett in District 5. Work will be confined to the southbound lanes and includes work at Exits 6, 7, 8, 9 and 10. Work starts at Br. No. 067/090 over I-293/FEET (MP: 26.1) in Hooksett and proceeds southerly to a pavement joint just south of Br. No. 169/124 (MP: 19.3) and a pavement joint on I-293 NB (MP: 0.2) in Manchester.

- 21519 - Manchester-Hooksett, I-93, Travel Way+1 BWC overlay (north) and Travel Way+1 BWC inlay (south), spot inlays, full width BWC overlays and HBP inlays on ramps, 12.4 miles

The proposed contingency amount is 5% of the contract amount. This project was quantified based on field observations, aerial photos, and as-built plans. Field adjustments may be required due to varying field conditions. In addition, the section will continue to deteriorate through the 2022-2023 winter.

Although the bid costs exceeded the Department's estimate by 8.02% the low bid of 3 bids received is felt to be reasonable for the work involved. There were 10 items of significance which accounted for 100% of the overage (paving (3), mobilization, cold planning, guardrail, bituminous curb, obliterate line, compost sock). The B-Bidder was less than 1% higher than the low bid submitted. Readvertising this project would result, in our opinion, in higher prices and prevent the completion of the work in a timely manner. The Department considers it to be in the best interest of the State to accept this bid to accomplish these needed repairs.


The Contractor has been prequalified by this Department. The Contract has been approved by the Attorney General as to form and execution, and the Department has certified that the necessary funds are available and the bid reasonably conforms to the engineer's estimate in accordance with State procedure. Copies of the fully executed contract are on file at the Secretary of State's Office and the Department of Administrative Service's Office, and subsequent to Governor and Council approval will be on file at the Department of Transportation.

This project funding is: 80% Federal, (Pave-T1-Resurf), with anticipated utilization of Turnpike Toll Credits for the State's 20% match, effectively using 100% Federal Funds.

A copy of the Tabulation of Bids received for this project is attached along with the Contract Supplemental Sheet and a map indicating the location of the project.

Your approval of this resolution is respectfully requested.

DESCRIPTION: This project is part of the Tier 1 Federal Resurfacing Program and involves 12.4 miles of pavement resurfacing on a section of I-93 in the City of Manchester and the Town of Hooksett in District 5. Work will be confined to the southbound barrel and includes work at Exits 6, 7, 8, 9 and 10. Work starts at Br. No. 067/090 over I-293/FEET (MP: 26.1) in Hooksett and proceeds southerly to a pavement joint just south of Br. No. 169/124 (MP: 19.3) and a pavement joint on I-293 NB (MP: 0.2) in Manchester.

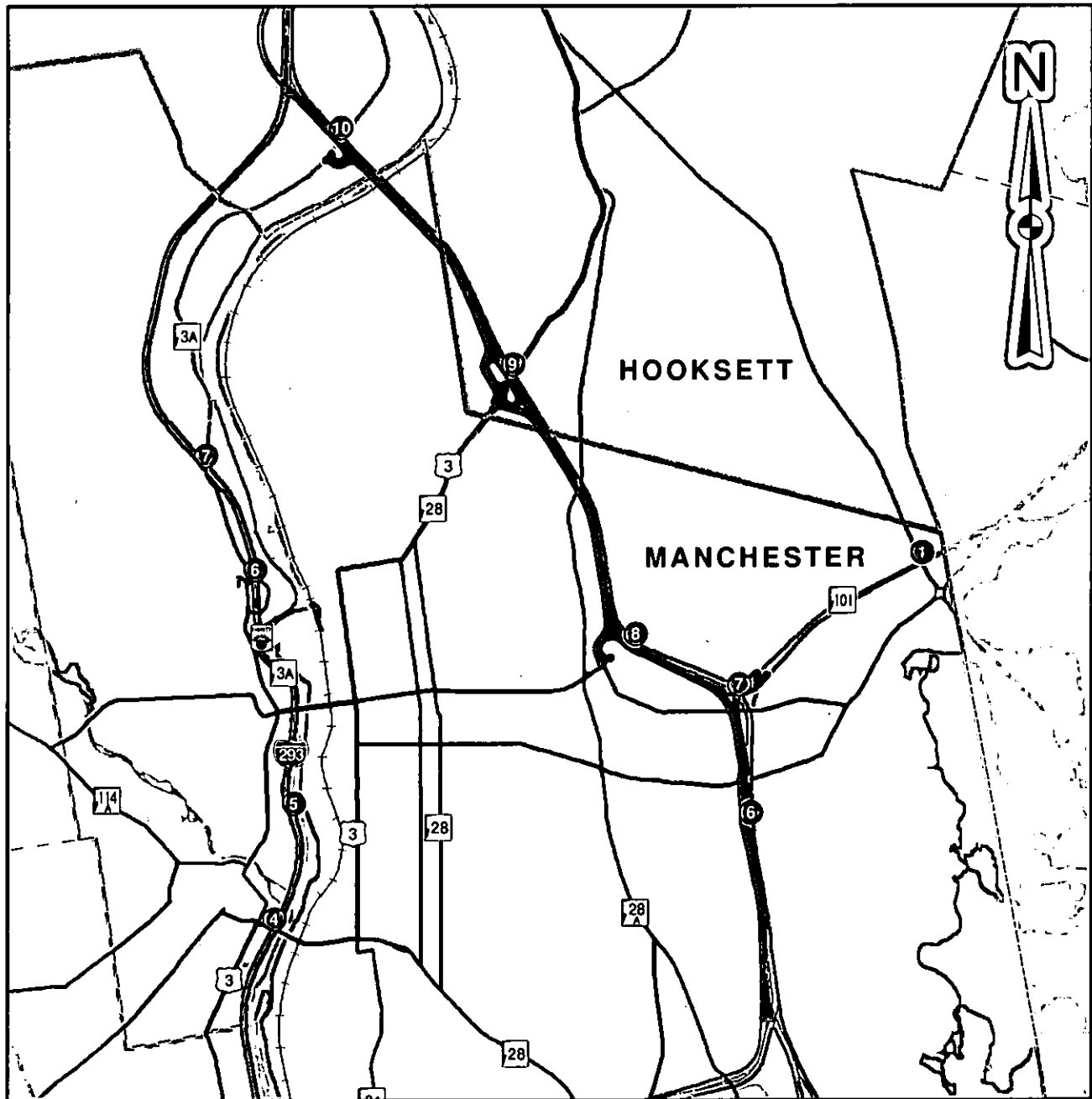

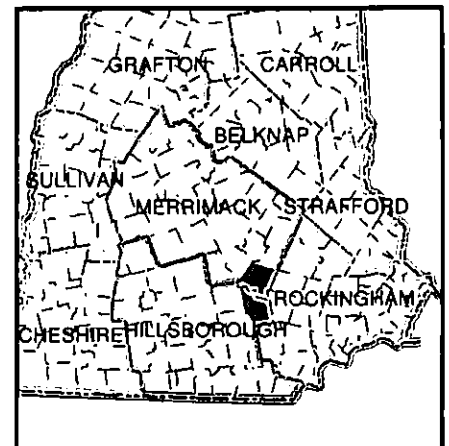

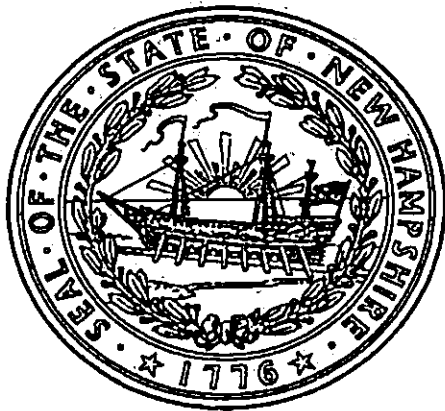
