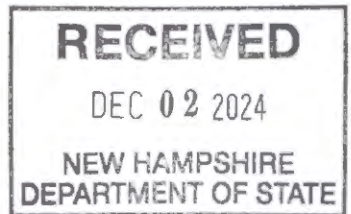



REEF Louisiana is an initiative of the Coastal Conservation Association started in 2019, to replace vital fisheries habitat across the coast of Sportsman's Paradise. Old platforms are replaced with new reefs in a manner that optimizes the conditions and creates the best possible fish habitat for both the species and anglers to enjoy.

11:30 - Noon (Capturing Revenue from Free/Discounted Licenses)

Revenue from sporting licenses is a crucial element for funding state fish and wildlife agencies' conservation efforts across the nation. However, well-intentioned programs to offer free and discounted licenses to certain qualified individuals/groups have the potential to reap deteriorative effects on the agencies' budgets. During the 2024 Session, Louisiana passed a bill that reimburses the Department of Wildlife and Fisheries for revenue lost as a result of the legislature passing new free or discounted hunting and fishing licenses.

12:00 pm 1:00 pm **Lunch - Sponsored by National Wild Turkey Federation**

National Wild Turkey Federation has evolved our conservation delivery to have landscape-level impacts through initiative-based work. NWTF has long been and still is a partner of several external initiatives, including those focused on longleaf pine, white oak, and young forests. We are also heavily engaged with the U.S. Forest Service with the Wildfire Crisis Strategy and the Natural Resources Conservation Service through our National Forest Initiative focused on private land habitats across the country. In recent years, we have established our own mission-centric initiatives focused on identified priorities within their respective geographies. These initiatives include the Rocky Mountain Restoration Initiative, co-convened with the Forest Service in the West, Waterways for Wildlife in the Great Plains, Forests and Flocks in the Northeast, and our Habitat for the Hatch Initiative in the Southeast. NWTF staff will provide an overview of our initiatives and explain why engaging in policy issues is important to successfully delivering our conservation work.

Hear from the regional leads from CSF's States Program Team members as they present on the activities of state caucuses, highlighting unique examples of events, communications deliverables, and key policy victories.

9:00 am 10:30 am **Breakout I: Conservation**

9:00 - 9:30 am (Dedicated Conservation Funding Mechanisms)

Despite the success of the American System of Conservation Funding, growing operational and habitat management costs have necessitated states to consider alternate and dedicated revenue streams to bolster the coffers of their fish and wildlife agencies. This session will discuss those dedicated conservation funding mechanisms and the lessons that state legislatures have learned in their passage.

9:30 - 10:00 am (Sustainable Forest Management – Opportunities to Improve Forest Health and Support Our Outdoor Sporting Heritage)

This session will explore forest policy issues impacting fish and wildlife habitat and access for hunters and anglers. Whether on private or public lands, active forest management is critical to creating quality wildlife habitat, increasing forest resiliency to wildfire and other threats, and supporting access for sportsmen and women. Speakers will discuss threats to sustainable forest management and initiatives to promote collaborative wildlife conservation, conserve private working forests, and increase active forest management on public lands, among other shared policy priorities for the sportsmen's community and forest industry.

10:00 - 10:30 am (Feral Hogs)

Feral hog populations are continuing to explode across the country. With an estimated 6 million individuals nationwide, they're having a profound impact on crops and privately owned property, causing an estimated \$2.5 billion worth of damage annually while also negatively impacting native wildlife and their habitats. As a result, some states have expanded recreational hunting of feral hogs while others have taken alternative approaches. Hear from our panel about eradication vs. management of feral hogs and how sportsmen can play a part in mitigating the problem.

9:00 am 10:30 am **Breakout II: Protecting & Promoting Our Sporting Heritage**

9:00 - 9:30 am (Closing the Loophole In Open Records Law)

Some have begun abusing open records laws to compel state wildlife agencies to produce geographically explicit data on individual wildlife, in an effort to make their hunts easier. Not only does that violate our fair chase ethics, it

also makes wildlife research more complicated. There is a simple fix to this issue, but it must be pursued legislatively.

9:30 - 10:00 am (Bringing International Voices to State Wildlife Trade Bills)

Actions in state capitols can have ripple effects across the world, negatively impacting wildlife conservation programs in other countries. Making sure legislators understand how their work supports or discourages wildlife conservation in other countries depends on engaging with people in far off capitols and communities. This panel will discuss the importance of such engagement and how it can be achieved.

10:00 - 10:30 am (Advancing the Social Contract Between Hunters & Society: The Interaction of Fair Chase Hunting and Wildlife Policy)

Hunters have restored most game species to sustainable levels, thus fulfilling the better part of our social contract with the rest of the country to restore species that were once at the brink of extirpation. Having accomplished much of this work, our task now turns to ensuring excellent management of these resources. This is best achieved by proactive policy development that incorporates biological science and field ethics to ensure hunting, fishing, and trapping are maintained.

11:00 am 11:30 am **Ballot Box Biology: State Initiatives That Impact Scientific Wildlife Management and the Pathway to Enact Supermajority Restrictions on Them**

"Ballot box biology" is the use of state-level ballot initiatives to make wildlife management decisions. These initiatives have led to the subversion of science-based wildlife management practices. Former NYS Assemblyman Colin Schmitt will review his soon to be published law note that serves as a legal guide to assist legislators and activists enact supermajority restrictions on this concerning practice.

11:30 am 12:00 pm **Improving Nationwide Venison Processing Capacity, One Butcher at a Time**

No species is perhaps more emblematic of our success in species recovery than the whitetail deer, however, our success has been so great that now we must address issues of abundance. In many cases, that includes removing deer from the landscape and getting that lean protein into somebody's freezer, but that's a whole lot more complicated than it seems. The National Deer Association and our partners are working to improve venison processing capacity across the country by streamlining regulations, connecting processors with resources, and advancing programs that deliver venison to those without enough food.

The Tools of Duck Production: Mesopredator Management

With the constant threat of trapping bans across North America in state legislatures and commission rooms, it's more important than ever to showcase what targeted predator management techniques can mean for boosting waterfowl production and populations by managing mesopredators on the landscape.

Predator management has proven to be the most effective and efficient approach to increasing duck production. Delta's research indicates that this tool is best applied across habitats with sparse nesting cover and intensive agriculture. Given agriculture's permanent place on the prairie landscape and the ongoing losses of nesting cover, ensuring robust duck populations hinges on responsible predator management.

Fishing

1:00 - 1:30 pm (The Quickly Evolving Landscape of Marine Electronics - Implications for Fishing and Management)
Forward facing sonar (FFS) has become an extremely hot topic in the fishing world, with major implications for fishing tournament competitiveness and overall fishing efficiency. This technology also presents tremendous opportunities for fisheries managers and researchers to accurately and less-invasively monitor fish stocks and behavior. The panel would discuss use of FFS and the importance of science-based management driving any potential discussions about regulating its use.

1:30 - 2:00 pm (Paddlecrafts and the Challenges They Present to State Agencies)
In general, state agencies — including TWRA and State Parks — provide access for paddle craft activities, but funding streams and infrastructure have not evolved to support public demand for these activities. Many TWRA boat ramps were designed before the popularity and steady growth of paddlesports, appropriate access points for paddlecraft must be updated or created to accommodate and protect the safety of motorized boaters and paddlecraft users. In order to help resolve some of the user conflicts that have arisen in recent years, we must modernize our infrastructure to address today's needs.

2:00 - 2:15 pm (Rigs-to-Reefs)
Over 7,000 oil and gas platforms have been constructed in the Gulf of Mexico (Gulf) over the course of the last 70 years. Over time, these structures have been the catalyst for teeming communities of fish and marine life that serve as incredibly important destinations for recreational anglers, divers, and commercial fishermen alike. Today, we have less than 1,100, remaining with over half of these platforms up for decommissioning in the next few years. We are working on legislation to more efficiently facilitate the conversion of these platforms to permanent artificial reefs.

Firearms

2:15 - 2:45 pm (Excise Taxes)
With gun control proposed constantly in state legislatures across the country, the National Rifle Association works every day to defend our Second Amendment rights. The NRA will overview nationwide trends and preemption and excise tax laws, including a Louisiana-focused discussion on firearms-related policy within the Pelican State. This session will discuss the importance of Second Amendment policies at the state level and their impact on hunting and recreational shooting.

2:45 - 3:15 pm (Positive Legislation for the Firearms Industry)
During the 2024 legislative session, Louisiana enacted the two priority pieces of legislation for the American firearm and ammunition industry. In doing so, the Legislature and Governor Jeff Landry helped refine the industry's statutory language into the current state-of-the-art models.

Darren LaSorte and Moriah Day with the National Shooting Sports Foundation (NSSF), the firearm industry trade association, will discuss these two critically important pieces of legislation and provide legislators from other states the guidance to follow Louisiana's example.

The Firearm Industry Non-Discrimination (FIND) Act is legislation intended to discourage the sort of corporate discrimination against the firearm industry that starves it of essential services such as banking, insurance, payment processing, and software. The most powerful corporations in the country seek to impose gun control policies that duly elected policy makers around the country refuse to enact, for good reason. The FIND Act denies taxpayer-funded contracts to the woke companies that engage in this discrimination. Taxpayers should not be compelled by the state to fund companies that seek to diminish their own constitutionally enshrined rights.

The Second Amendment Financial Privacy Act protects against the government monitoring and investigating citizen purchases of firearms and ammunition. A Merchant Category Code (MCC) is assigned to retailers and is intended to describe the kinds of goods or services a retailer sells. The international body that creates these codes recently established a code unique to firearm and ammunition retailers with the stated intent of being able to monitor purchases by American consumers. This legislation expressly prohibits financial institutions and credit cards from requiring firearm and ammunition retailers to use this new MCC. They may continue to use the general MCCs they have always used – associated with “general merchandise” or “sporting goods.”

Established with the dedicated purpose of protecting and conserving wildlife, game commissions have been understandably staffed by experts in the field throughout their existence. Such experts' ability to make responsible and effective decisions regarding wildlife management has become contested through non-sportsmen and women pushes for representation on game commissions. Having board members that are neutral on the matter or even directly oppose hunting, trapping, and fishing leads to obstructionism, which in turn will potentially restrict access and opportunity for sportsmen and women.

4:00 - 5:00 pm (Director's Panel)

State Fish and Wildlife Agency Directors will reflect on topics from the Summit and describe legislative challenges and victories from their respective states.
