**REQUESTED ACTION**

Pursuant to RSA 14:30-a, VI, authorize the Department of Justice to accept and expend a grant in the amount of \$200,000 from the Bureau of Justice Assistance, Office of Justice Programs entitled Project Safe Neighborhood (PSN) for the purpose of reducing violent gun and gang crimes in New Hampshire upon Fiscal Committee and Governor and Executive Council approvals through June 30, 2019. 100% Federal Funds.

**EXPLANATION**

The New Hampshire Department of Justice (DOJ) is seeking approval to accept and expend funds from the FFY 2017 Project Safe Neighborhood (PSN) grant in order to embark on a multifaceted, research driven approach to reducing gun and gang crime in the greater Manchester area.

There are four main components to the PSN project:

1. Stemming the flow of illegal guns purchased throughout the State.
2. Focusing on gun and gang crime offenders through collaboration with federal, state, and local law enforcement.
3. Enhancing patrols and parole checks.
4. Providing outreach on gun and gang crime with a focus on deterring gun and gang crimes throughout the Manchester NH area.


