The Board wishes to remind that the use of the word "Absolute" in the context of auction advertising has a very specific connotation and should not be used in any manner which may cause confusion or mislead the reader.

Auc 102.01

(a)"Absolute auction" means an auction without reserve in which the property offered for sale is sold to the highest bidder; where no minimum price will limit the bid; where the seller does not withdraw the property from the auction after the first bid has been made by a registered bidder and accepted by the auctioneer; and where the seller does not participate in the sale by bidding himself or through an agent.
