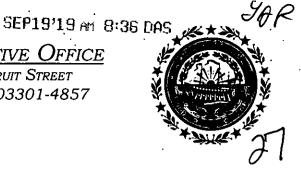

## **EXPLANATION**

This request is retroactive because the plan for the level of outreach was not established until June 24, 2019. Once requested, DHHS and NHES immediately developed a plan to ensure enrolled New Hampshire Granite Advantage Program members had information regarding the Work and Community Engagement requirements set forth in NH RSA 126-AA and NH Administrative Rule He-W 837.

NHES and DHHS collaborated to perform an array of outreach activities, including door-to-door and community engagement sessions to connect with individuals who were subject to the Work and Community Engagement requirements for whom DHHS did not have the required documentation for participation or exemption from the program.

NHES trained staff conducted door-to-door and other community outreach efforts to:

- Explain the Work and Community Engagement requirement of the New Hampshire Granite Advantage program,
- Detail the options for compliance and exemptions from the Work and Community Engagement;
- Assist members with the completion of necessary forms;
- Collect the necessary forms and provide to DHHS for processing;
- Provide ways for members to contact DHHS to check on the status of their submission of forms;
- Provide information for members to access the NH Easy system so they can access the system for information, to report hours, and to complete forms; and
- Offer a call from a DHHS employee to provide additional assistance.

NHES is requesting authorization to retroactively accept and expend \$42,219.55 in funds from DHHS, for NHES staffing related costs for providing outreach activities, and to budget the funds as follows:

Class 050 Personal Services – Part Time will be used to support a portion of the existing full-time permanent staff involved in the project.

Class 060 Benefits will be used to cover the benefits cost associated with the positions involved in the project.

Class 070 Travel In-State will be used to support the travel-related costs associated with the project.
