**REQUESTED ACTION**

Authorize the Department of Health and Human Services, Bureau of Human Resource Management to make a **retroactive** one-time payment from State Fiscal Year (SFY) 2019 funds to Mary Galatis, Chief Pharmacist, at New Hampshire Hospital in the amount of \$2,112.26. This payment is to compensate the employee for wages that were not paid for State Fiscal Year 2018. The funds to be paid will be thirty-four percent (34%) General Funds, twenty-one percent (21%) Federal and forty-five percent (45%) agency income (provider fees). 
**EXPLANATION**
