Dear Governor Hassan and Council:

Consistent with the requirement of RSA 383:15, I am pleased to submit the 171st Annual Report of the Bank Commissioner, for the calendar year 2015.

As the New Hampshire economy continues to recover from the recession, its state chartered financial institutions and licensed consumer credit companies are well - positioned to serve the state's growing and diverse financial needs. In 2015, New Hampshire depository bank and credit union assets grew 9.4% to over \$14 billion. Deposit volume grew 9.4% and loan volume grew 9.1%. Overall, capital positions remain well within regulatory parameters. Additionally, New Hampshire was the site of one of the first de novo depository banks to be chartered in the country since the recession began in 2008.


Trust companies continued their steady growth, ending the year with almost \$460 billion in total assets under management, an increase of 9%. The trend of growth in this area is expected to continue. The Department expects to receive several applications and to charter at least three new trust companies and family trust companies in 2016.

There was growth in the number of non-depository licensed mortgage bankers, sales finance companies, and money transmitter registrants, but other types of licensed consumer credit entities trended downward slightly. This includes debt adjusters, mortgage brokers, mortgage servicers, retail sellers, and small loan lenders. The Department continues to pursue cost savings by working with fellow state and federal regulators to perform joint and concurrent examinations on larger, nationally-present consumer credit entities. The Department's legal enforcement unit collected approximately \$625,000 in administrative penalties and was able to obtain about \$140,000 in restitution that was returned to New Hampshire consumers. Additionally, the examination team identified over \$49,000 in overcharges which were returned to New Hampshire consumers.

Fortunately, foreclosure volume in New Hampshire declined in 2015 to approximately the 2007 level, before the mortgage crisis occurred, and the housing market has begun to recover. The Department continues to assist homeowners who are experiencing mortgage foreclosure issues. 2015 marked the third year of the statewide HomeHelp NH initiative, supported with funds from the National Mortgage Servicing Settlement. The initiative and the 211 support hotline continue into 2016 with remaining funds and support from industry.

New Hampshire's financial institutions remain strong and diverse, and ready to serve the citizens of New Hampshire's banking and credit needs.



Foreword

The one hundred seventy-first annual report of the Bank Commissioner contains management, financial information and locations of banks, credit unions, and other financial institutions operating under state charters. This report also contains information concerning debt adjusters, money transmitters, mortgage bankers and brokers, mortgage servicer registrations, retail sellers, sales finance companies, and small loan lenders.

Mission Statement

The New Hampshire Banking Department is committed to protecting the public's interest through the professional supervision of the financial services it regulates.

Functions of the Banking Department

The Bank Commissioner is responsible for the general supervision of all New Hampshire chartered financial institutions. These institutions include commercial banks, fiduciary trust companies, family trust companies, mutual savings banks, guaranty savings banks, co-operative banks, and credit unions. The Commissioner is also charged with the licensing and supervision of non-bank mortgage lenders and brokers, money transmitters, mortgage loan servicers, retail sellers, sales finance companies, small loan, title loan, payday lenders, and debt adjusters.

State laws mandate that the Department conduct periodic examinations of each financial institution and licensed lender and broker to ensure sound financial management and compliance with state and federal laws and regulations.

The Department is responsible for the investigation of branch applications, new bank applications and conversions, merger and consolidation applications of state chartered institutions. The Department investigates consumer complaints on the entities it regulates, and also investigates complaints of unlicensed activity. The Department is authorized to bring administrative actions against licensed and unlicensed entities for violations of state banking and consumer credit laws.





NH's Asset Distribution by Institution Type for 2015 (\$ thousands)




NH Asset Distribution - Five Year Trend (\$ thousands)




NH Loan Trend - Five Year
(\$ thousands)




NH Deposit Trend - Five Year
(\$ thousands)




Consumer Credit Division Licenses




Consumer Credit Division Money Transmitter Registrations





Mortgage Loans by Type




