**REQUESTED ACTION**

Authorize the Department of Transportation to enter into a contract with Pike Industries, Inc. of Belmont, NH (Vendor 177300) on the basis of a low bid of \$3,424,196.75 for resurfacing ten (10) sections of various Tier 2, 3 and 4 roads throughout 11 towns, including: Pinkham's Grant, Greens Grant, Conway, Bartlett, Bethlehem, Whitefield, Haverhill, Bath, Albany, Lincoln and Easton, in Districts 1, 2 and 3 (Project: District 1 S 43524), from the date of Governor and Council approval through September 23, 2022, unless extended by the Department in accordance with the Standard Specifications. 9.94% General Funds and 90.06% Other Funds (Betterment and SB367).

Funding is available in State Fiscal Year 2022 and 2023, with the ability to adjust encumbrances through the Budget Office between State Fiscal Years if needed and justified:

**EXPLANATION**

This project is included in the State's Ten-Year Transportation Improvement Plan, under the State funded Tier 2, 3 and 4 Resurfacing Programs (Pave-T2-Resurf & Pave-T3/4-Resurf). This project resurfaces 10 sections of various Tier 2, 3 and 4 roads throughout 11 towns in Districts 1, 2 and 3. The sections total approximately 32.3 miles in length, including nine (9) sections with Light Capital Paving totaling 31.1 miles, and one (1) section with Preservation treatment totaling 1.2 miles. Incidental work includes curb ramp reconstruction, pavement striping, X-Lite guardrail end unit replacement, and minor drainage work.



**PROJECT INITIATED:** This project is part of the CY 2022 state funded Tier 2, 3, and 4 resurfacing program (Pave-T2-Resurf & Pave-T3/4-Resurf). The Pavement Management Section has reviewed the road segments in this project and identified nine (9) sections for Light Capital Paving totaling 31.1 miles, and one (1) section for Preservation totaling 1.2 miles.

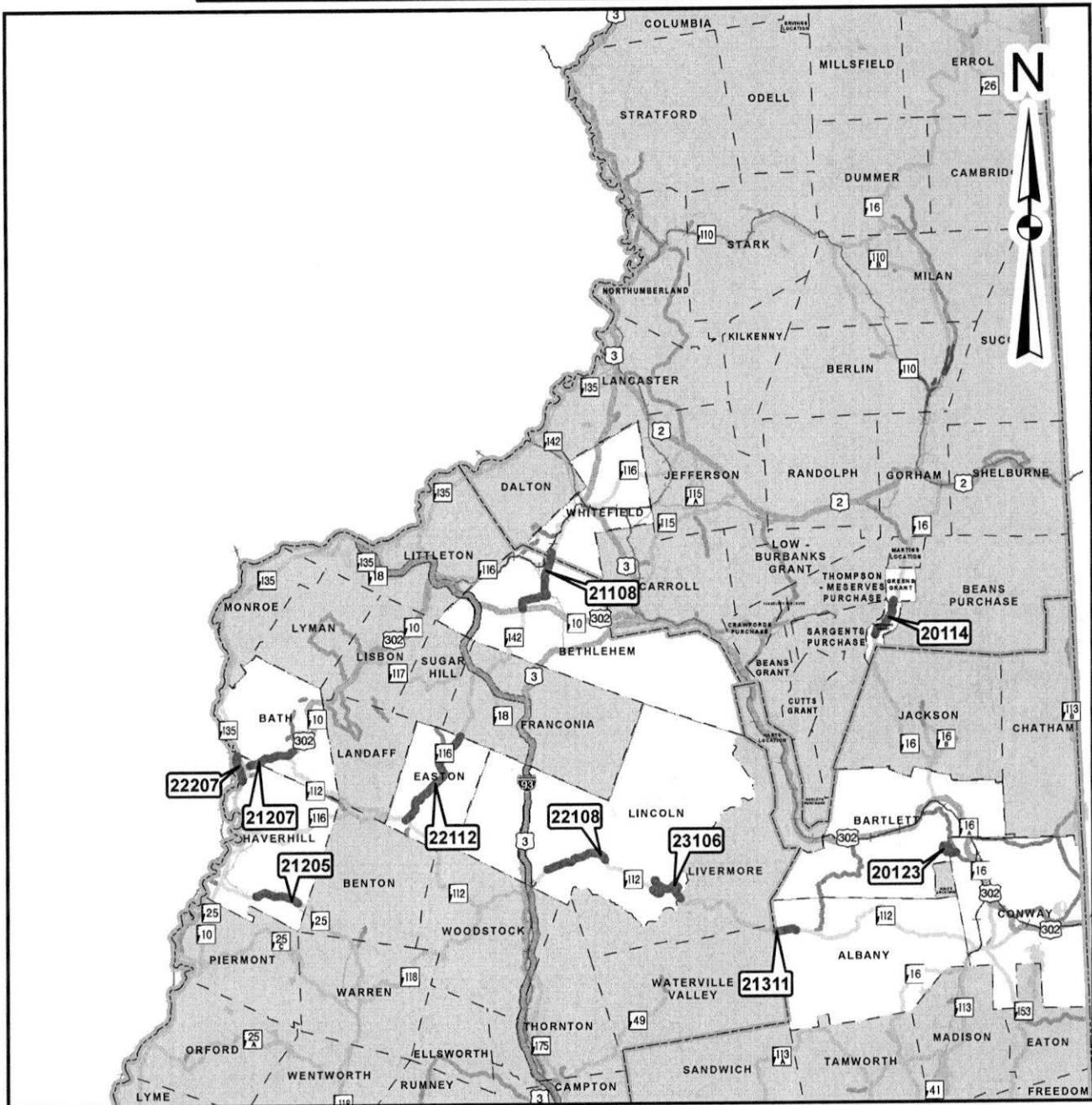
**PROJECT EXPLANATION:** This project will improve the roadway ride quality, extend the life of the pavement, improve guardrail, curb ramps, and drainage; and delay costlier improvements. The sections will be resurfaced via paver shim overlay, paver shim inlay, winter binder overlay, and high strength inlay. Ten (10) sidewalk curb ramps will be upgraded to comply with ADA guidelines. Nineteen (19) X-Lite guardrail end units will be replaced. All impacted towns and utilities will be notified.

**TRAFFIC IMPLICATION:** Only one section will be paved at a time. One-lane, alternating two-way traffic will be required to complete the work. Unless otherwise noted in segment specific requirements, lane closure lengths will be limited to one mile with a two-mile separation required between work zones. Traffic will be restored to normal patterns during non-work hours. Section 20123 (Cathedral Ledge Rd, Conway-Bartlett) will be closed for the duration of work. Work zone significance was determined to be non-significant at the December 17, 2020 TCC Meeting.

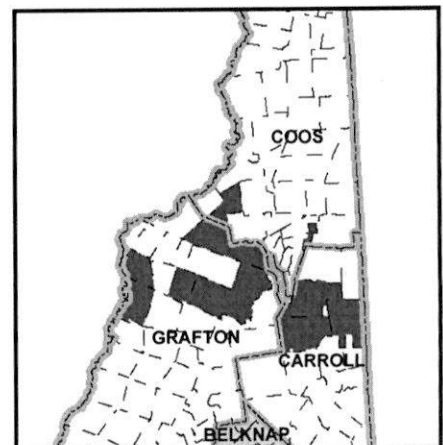
