

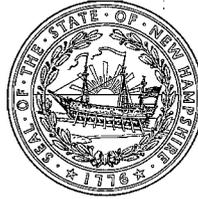

REQUESTED ACTION

Authorize the Department of Justice (DOJ) to accept and expend \$5,000 from the American Bar Association, Section of Antitrust Law, 321 North Clark Street, Chicago, Ill., for the purpose of providing funds to support an intern in the Consumer Protection and Antitrust Bureau for the summer of 2013 from the Janet D. Steiger Fellowship Project. This request will be effective the date of Governor and Council approval through September 30, 2013. 100% Agency Income.

EXPLANATION

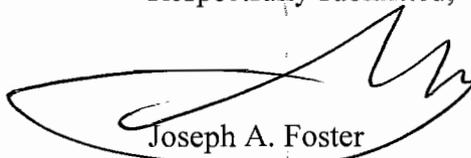

RE: New Hampshire - 2013 Janet D. Steiger Fellowship Project – Payment

We are pleased to enclose our \$5,000.00 payment to be used for Ms. Laurie A. Smith, the 2013 Janet D. Steiger Fellow selected by the Office of the Attorney General of the State of New Hampshire.

We would also appreciate your state's adherence to the following:

- This will confirm that Ms. Smith's Steiger fellowship is for a minimum of 8 weeks; and at least one-half of her work must be devoted to consumer protection matters. The remainder of her time, if your state wishes, can be devoted to antitrust matters.
- A written evaluation must be completed by the Office of the Attorney General of New Hampshire and submitted via e-mail to Deborah.Morgan@americanbar.org at the ABA Section of Antitrust Law and to Bob Langer at rlanger@wiggin.com no later than one week after Ms. Smith's last day.
- A written evaluation must, also, be completed by Ms. Smith and submitted via e-mail to Deborah.Morgan@americanbar.org at the ABA Section of Antitrust Law and to Bob Langer at rlanger@wiggin.com no later than July 22, 2013, or her last day as a Steiger Fellow, whichever comes first.

- Note: Please reiterate to Ms. Smith so that she clearly understands that she is solely responsible for paying federal and state taxes on the \$5,000.00 stipend she receives from your state unless your office retains the tax. In some instances, this may mean that she must file a 1099 form with the IRS.
