#### **EXPLANATION**

The NH Department of Safety incurred personnel labor costs at the Division of Homeland Security in order to open and operate the Emergency Operation Center (EOC), as well as added patrols by State Police to block roads which were not passable and provided additional security to protect residents and prevent damage to public and private property during the March 2018 Severe Winter Storm declared disaster. During the incident period, New Hampshire experienced excessive heavy snow and high wind weather, which resulted in extensive damage throughout Carroll, Rockingham, and Strafford counties.

The awarded amount of \$10,130.00 represents the 75% federal share of the total approved eligible costs. These costs were incurred in SFY 2018; however, due to the timing of the award to the Department of Safety, funds will be used to offset SFY 2022 expenses.

Funds are to be budgeted in the following accounts:

Class 018 These funds were used for labor costs incurred by DOS to open and operate the State Emergency Operation Center (SEOC) and responding around Carroll, Rockingham, and Strafford Counties to protect public safety during and after the event

Class 020 These funds were used for costs incurred in order to open and operate the Emergency Operation Center including food for employees working in the EOC.

Class 039 These funds were used for costs incurred in order to open and operate the Emergency Operation Center including conference calls.

Class 060 These funds were used for the benefit costs associated with the above labor expenses.

Class 070 These funds were for costs incurred to operate DOS owned equipment during the disaster response, including . HSEM Field Representative's vehicles and State Police cruisers.

Class 103 These funds were for costs incurred for Information Technology support at the SEOC during the activation.

There are no General funds required with this request. In the event that Federal funds are no longer available, General funds and/or Highway funds will not be requested to support this program.
